# Twenty-Nine SJCL Grads Pass July, '92 Bar Exam

**T**wenty-nine of the 40 San Joaquin College of Law graduates who sat for the California Bar exam last July have passed on their first attempt, posting a 72.5% pass rate. Congratulations!

Exam results began arriving as early as November 21 to an anxious group of graduates. The good news also prompted the traditional "Champagne-in-the-SJCL-parking lot" celebration on November 23.

According to the Committee of Bar Examiners, the overall statewide average pass rate for the exam was 59.4 percent – up 4.5 percent from last year. At the time of publication, figures for individual law schools in California were not yet available.

Preliminary statistical analyses show that the pass rate for first-time applicants from ABA-approved law schools was 79.7 percent, while the pass rate from non-ABA approved law schools was 48.9 percent. For repeating applicants, the pass rates were 28.4 percent of the 638 applicants from ABA-approved law school and 15.2 percent of the 1,198 applicants from non-accredited schools.

A total of 7,130 applicants took the July, 1992 exam. This year, the test consisted of three sections: a multiple-choice Multistate Bar Examination (MBE), six essay questions and two performance tests designed to test an applicant's abilities to apply general legal knowledge to practical tasks.

Official swearing-in ceremonies for new members of the local Bar were held in Fresno on December 9, 1992 in a joint ceremony of the California Fifth District Court of Appeal and the U.S. District Court, Eastern District of California.

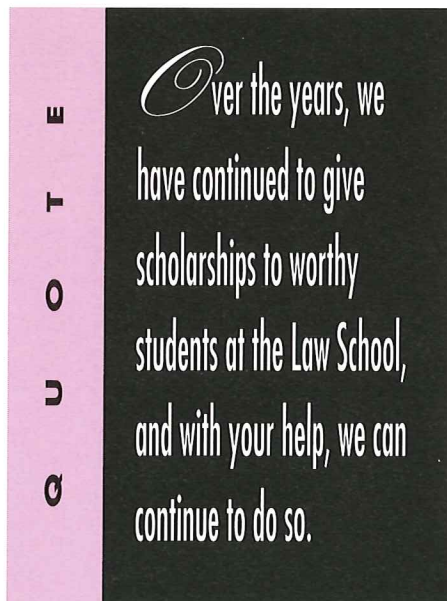

## Time Capsule Records Snapshot of Hmong Life in Fresno

November 25, 2042 will be a special day for the San Joaquin Valley Hmong community.

Fifty years from now, members of our community will gather at the Fresno Metropolitan Museum to open a time capsule that was sealed during a special ceremony last November.

Deposited into the time capsule were a host of items representing a cross-section of Hmong life: photographs, writings, copies of the first Hmong newspaper, traditional Hmong costumes, artwork, a chronicle of the Hmong migration from Laos to Fresno and many other personal effects.

Bill Erysian, SJCL's Director of Institutional Relations, also placed into the time capsule a copy of the "Law and Legal Survival Skills" educational videotape. The Law School produced the series of tapes last year as part of a grant from the U.S. Department of Education to assist the Hmong community in understanding American laws and the U.S. legal system.

The time capsule ceremony was held in conjunction with a photo exhibit at the Met entitled, "One Common Experience: Daily Life in a Hmong Refugee Camp." The exhibit chronicled the experiences and photographic impressions of Museum Guest Curator Brigitte Marshall, who had worked at the Phanat Nikhom refugee camp in Thailand. She is currently the Refugee Program Coordinator at Fresno City College. ■

# 1992 Hopper Competition Results

The 1992 George A. Hopper Moot Court Competitions brought together the largest number of participants to date, featuring 39 teams (78 students) from the Law School.

The semi-finals and finals of this annual SJCL-sponsored event were once again held at the Fifth District Court of Appeal last November, with Justices Hollis Best, James Ardaiz and James Baxter hearing arguments. Earlier rounds were held at the Fresno County Courthouse.

According to SJCL Moot Court Director Sarah Schmidt, based on student performance, this was the most successful Hopper Competition yet. Some 70 percent of the students had a cumulative average oral score of more than 80 percent and 30 percent had a cumulative average of more than 85 percent.

The Overall First Place award was won by the team of Mark Pasculli and Allen Bennett. The team of Karen Mathes and Gayle DeLapp received second place honors.

Semi-finalists in this year's competitions were the teams of Joan Levie/David Rendahl and Ed Fanucci/Lisa Sondergaard.

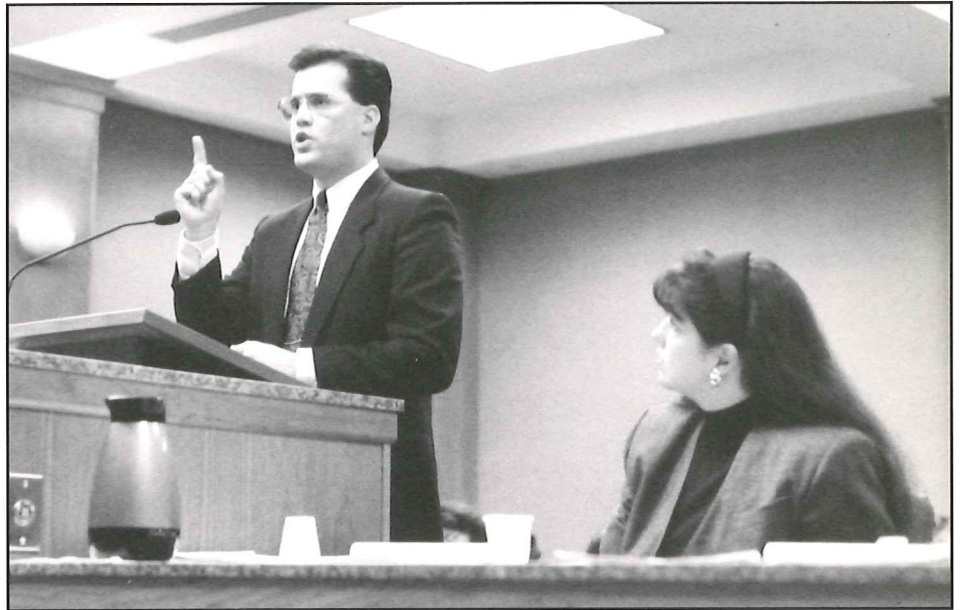

## Paralegal Profile: Lillian Richardson

Lillian Richardson graduated from the SJCL Paralegal Program in the fall of 1984 with about 20 other classmates. She immediately began looking for work and discovered that only the very large firms were hiring paralegals – at about half the salary she was currently earning in her non-legal profession.

She continued for about three years in non-legal employment until her business background prompted her to begin “freelancing”. Lillian spent several years working with a small firm of corporate attorneys producing minutes, letters, notices and other requirements of corporate entities. Although the salary and the hours were good, Lillian missed the people aspect of her work.

In January, 1989, Lillian became aware of a position with the State of California that called for a support person for a unit of medical fraud investigators. It was a great match that continues to this day. Through the state transfer system, she also spent a year working with the highway patrol before returning to her investigative unit.

According to Lillian, the medical frauds unit deals with a variety of situations, including fraudulent billing by medical providers, falsified use of prescriptions, undeclared insurance coverage while on Medi-Cal, and other “interesting illegal acts.”

She likes her role as support person for the investigative team, all of whom are law enforcement officers. Her job duties include background checks through various computer data bases, researching what statutes are involved in defining specific charges, and serving as liaison with the Department of Justice and Bureau of Narcotics when companion cases are involved.

Lillian says her job is different from her original vision of what she would do with her paralegal education. But she has found a real home and insists that if she ever changes her position, it will still be with a state or federal agency. ■

# Final WASC Visit Yields Positive Outlook For Accreditation

*During November 10–13 of last year, a monitoring team from the Western Association of Schools and Colleges made its final visit to SJCL. The purpose of the visit was once again to review the work of the college measured against the nine Standards established by the WASC Commission. Below are excerpts from the team's analyses and findings that have been submitted to the WASC Commission, which is expected to make its decision in February of this year.*

*We are pleased to report that the team has recommended to the Commission that Initial Accreditation be granted to SJCL.*

## ***On SJCL:***

"... San Joaquin College of Law fills a need for a legal educational facility in the Valley. It provides the opportunity to get a legal education for those who will not or cannot leave the area. It is becoming a center for continuing education for the local bench and bar. Over time, it can become a source of ideas and scholarship on topics of importance to the area, such as agricultural and environmental issues."

"... The track record of the College over a number of years has been good. By all account, they have produced good lawyers."

## ***On Institutional Integrity and Diversity:***

"... The Team noted that SJCL in all its constituencies is highly sensitized and committed to the concept of diversity. Indeed, the institution's actions and commitment are far stronger than the non-discrimination statement that is part of the institution's policy."

## ***On Institutional Effectiveness:***

"... It is easy for a law school to point at the bar examination pass/fail percentages as a comprehensive measure of the effectiveness of a legal education. By this measure, the College's performance is impressive."

"... In discussion with many elements of the legal community, it became apparent to us that the institution and its graduates are respected as technicians and practitioners."

## ***On Governance and Administration:***

"... The College has also made important improvements in its organizational structure and operations. Over the past six years, a number of WASC teams have made recommendations on a wide variety of matters, ranging from the broadening of participation in governance to the need for additional full-time faculty members... Especially in the last two years, a great deal has been done by the College to define the role of Board, administration and faculty."

"... The administration of SJCL is perceived by the community to be extremely sensitive and accessible. It is gratifying to observe the excellent relationships within the institution, with the administration setting the tone."

## ***On Educational Programs:***

"... We were very favorably impressed with the emphasis placed on writing. There are substantial required writing assignments each year. In addition, a number of electives courses require writing. Faculty interest in this area was particularly high."

"... The College appears to be carrying out its mission of admitting the right people and giving them the kind of education that enables them to enter the legal profession."

"... The recent addition of a Law Review dedicated to agricultural issues enriches the experience of the students who qualify as well as focuses attention on local issues in a way which will both add to the practical solutions of problems in the basic industry of the area and bring pres-

tige and recognition to the school."

"... The students we talked to spoke highly of their teachers. Many particularly mentioned the advantages of having a number of teachers who are judges and practicing attorneys, because they add a hands-on perspective to what is presented in the textbooks."

"... In view of the very high passage rate of the bar exam by College graduates, we did look at whether the curriculum was somehow oriented toward passing the bar and thereby detracting from some broader benefits of a legal education... This does not appear to be the case."

## ***On Faculty Issues:***

"... San Joaquin College of Law presents a highly unusual case of how adjunct faculty relate to the institution... First, the adjuncts are persons of high personal and professional caliber... Second, a significant portion of the adjuncts have demonstrated a commitment to the institution and the willingness to spend the time needed for the institution... Third, the adjuncts feel a sense of participation and 'ownership' in SJCL, in a manner similar to full-time faculty... Fourth, the adjuncts appear to have 'academic values' similar to those persons who choose a full-time academic career..."

## ***On Library and Computing Facilities:***

"... Of special significance is the fact that legal materials are exceptionally well-organized and accessible through electronic data banks such as LEXIS, which is in almost universal use by faculty and students." ■
