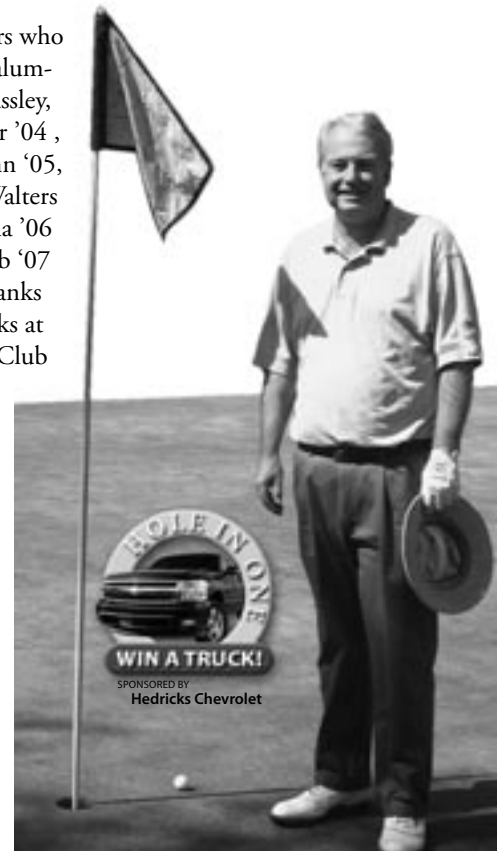

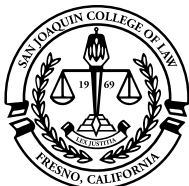


Cristina Jelladian, Alumni Association Representative

On March 13, 2007 Governor Arnold Schwarzenegger announced the appointment of Kimberly J. Nystrom-Geist to a judgeship in the Fresno County Superior Court. Kim Nystrom-Geist, a 1992 alumni and Valedictorian of her class, has served as a commissioner with the Fresno County Superior Court since 2005. Prior to her appointment as commissioner, she was a partner with the law firm of Leslie-Soley & Nystrom-Geist from 1998 to 2003. Kim had worked as a law clerk in the office of Judith Leslie-Soley from 1990

to 1993 during law school and became an associate in the firm in 1993. Nystrom-Geist received her Bachelor of Arts degree in Speech Communications from California State University, Fresno prior to enrolling at SJCL. She fills the vacancy created by the retirement of Judge Ralph “Chip” Putnam. Kim continues to contribute to academics at SJCL; she currently is an adjunct professor of law, teaching both Advanced Research and Writing and Family Law. When time permits, Robin provides mediation services for the Victim Offender Reconciliation Program and consults with the State Department of Social Services on the issue of Shaken Baby Syndrome prevention.

As the daughter of a SJCL Class of 1976 alum and sister-in law to a 1985 alum, Robin is looking forward to getting to know all of our alumni and taking the journey with SJCL to being ABA accredited and building the new law library.

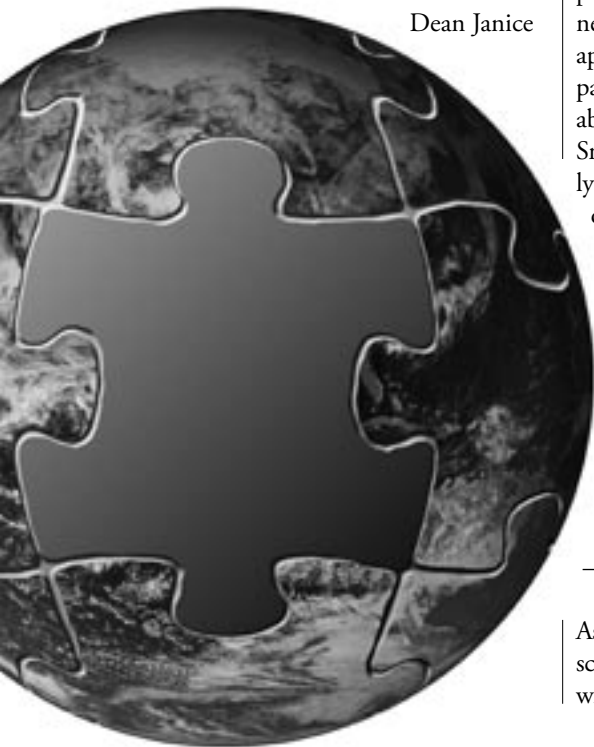

As alumni and donors of the law school you probably know someone who would be a good student candi-

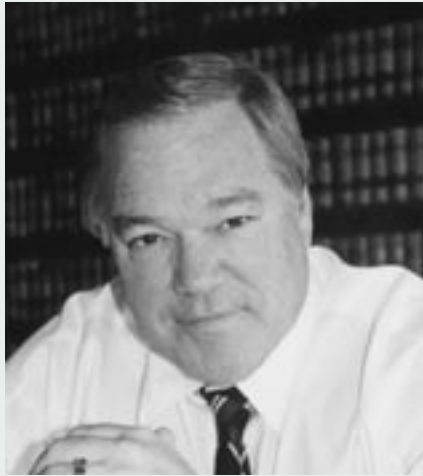

At the March 23rd Barristers' Ball there was great excitement around the unveiling of the new SJCL Alumni Hall of Fame. Graduating student Margie Webb worked tirelessly on getting the idea up and running. Criteria for the Hall of Fame had to be specified, a nomination process formed and a selection committee created. As the Student Bar Association liaison she approached the Alumni Association with the plan. They embraced the idea and this remarkable recognition will now be an annual occurrence.

This first year, Ernest S. Kinney '75 and Theodore Forrest, Jr. '77 were honored. Margie worked with the families of the inductees to produce an amazing collage of their lives. She got help from her photographer husband, Ron, and the result was extraordinary. The honoree plaques will hang in a special location at the entrance of the law school.

In the late 60's, Mr. Kinney enlisted in the Marine Corps and served as a captain during the Vietnam era for three and one-half years. Upon his discharge from duty in 1971, he returned to Fresno.

While working as a social worker during the day, Mr. Kinney attended San Joaquin College of Law in the evenings and received his Juris Doctorate in 1975. Mr. Kinney began his law career at the Fresno County Public Defenders Office. After practicing there for two and one-half years, he helped form the law firm of Cowin, Johnson, Brewer, Tibbs and Kinney. In 1980, he started the Ernest S. Kinney Law Corporation and has been sole practitioner there since. His dedicated secretary of 25 years, Sharon Fuller, assists him by picking his juries during trial. He is a member of the California Bar Association and California Attorneys for Criminal Justice. He has also provided generous scholarship support to SJCL since 1952. He was joined at the event by his wife, Marion Didier Kinney, son, Scott, and many friends and colleagues.

The second honoree was Ted Forrest, who passed away in 2001. Mr. Forrest served as an adjunct professor at San Joaquin College of Law from 1979 to 1983, while also teaching at Humphrey's College of Law, Fresno City College, and Fresno State. He represented Farmers In-

urance Co. nationally. He co-authored *Environmental Health Law* and *California Title Insurance Practice*. Mr. Forrest served as Secretary and Trustee for San Joaquin College of Law, Judge Pro Tem, and Arbitrator for the Fresno County Superior Court. He was a member of the Fresno County and American Bar Associations, State Bar of California, Association of Trial Lawyers of America, Association of Defense Counsel of Northern California, Defense Research Institute, and Association of Business Trial Lawyers. Friends of Ted have created an SJCL scholarship in his honor. Ted and high school sweetheart, Susan Buchanan, raised seven sons. He considered his office staff family too. Five of his boys, Steve, Brian, Chad, Scott and David, his former wife, Sharon Markland, and Kay Sealy, his long-time secretary, were present at the Ball to receive his plaque.

San Joaquin Agricultural Law Review

The Law Review is one of very few law reviews in the country dedicated solely to agriculturally related legal issues.

The *San Joaquin Agricultural Law Review* provides an objective, national forum for analyzing legal issues affecting our nation's most vital industry – agriculture.

Over the years, the Law Review has earned respect in the legal community as a forum for the discussion of the intersection between agricultural and legal issues. The quality of the Law Review produced each year is evidenced by the fact that it has been mentioned frequently in National Law Journal's "Worth Reading" column and is featured in Westlaw® and LexisNexis®.

The Law Review has also received judicial and critical recognition; its articles have been cited by the California Supreme Court, the California Appellate Court, the United States District Court, the New Mexico Court of Appeals, the Middle District of Tennessee and the Minnesota Supreme Court. Articles have also been cited in the annotations of several California statutes.

Last year's Editorial Board is currently finalizing the sixteenth volume of the Law Review, which will be published in June. It will feature an article by John Becker, Matthew Kaplan and John Nussbaum, professors at Pennsylvania State University, entitled "Family Farm Succession Planning: Balancing Professional Responsibility with Client Needs for Help with Family Relationship Issues." In addition, this volume will feature a book review written by Amy Guerra, the Law Review's former Executive Editor, of "Capers In The Churchyard: Animal Rights Advocacy in the Age of Terror" and a comment entitled "Food for Thought or Terror: The Legal Issues Surrounding Agroterrorism" by Dr. Shelia Fleishhacker, a law student at Loyola University

Chicago School of Law. Also included in this volume will be San Joaquin College of Law student comments on the following topics: the impact of child farm worker laws on the American taxpayer; the National Uniformity for Food Act; the effect of big box sprawl on farmland and rural communities in the Central Valley; the failures of the U.S.'s Guest Worker Programs; the Clean Water Act's application to cranberry growers; agroterrorism and the safety of imported produce; the impact of the No Child Left Behind Act on rural school districts; and agricultural exceptionalism as it relates to land use.

As the new Editor-in-Chief of the Law Review, I am pleased to announce that the 2007-2008 volume of the Law Review will be devoted to writings concerning the current and crucial topic of global climate change as it relates to agriculture. In light of the U.S. Supreme Court's unexpected decision in *Massachusetts v. EPA*, (2007) 127 S. Ct. 1438, which held that the Clean Air Act authorized the EPA to address global climate change, there now exists a serious national debate on how to address global warming through the regulation of greenhouse gases. The Law Review will be on the forefront of this discussion by presenting articles and comments, written from diverse points of view that address the effects of global warming, if any, on agriculture and its related industries.

This year the Editorial Board, which includes in addition to myself, Peter Wall, Brooke Sorensen, Matt Schmidt, Rhea Ikemiya and Wendy Aguilar,

will be looking for support from San Joaquin College of Law and its alumni to publish a meaningful and thought provoking volume, as well as improving the overall operation of the Law Review for the longer term.

The Law Review is sustained to some degree by its regular subscribers and the financial support it receives from the alumni of San Joaquin College of Law. We hope to greatly expand both our subscription base and the number of generous donors willing to support the Law Review and its continued presentation of timely topics of vital interest to both the legal and agricultural communities. 1977 Ronald D. Smith

Upon graduation, Ronald entered a small-town legal community of about 600 attorneys and has seen it flourish into a league of professionals. Though the times have changed since he first hung out his shingle, his love for the law and the Fresno law community has not.

Growing up in rural Oklahoma, Ronald spent his youth enjoying traditional farm life. He later attended the University of Northeastern Oklahoma, graduating with degrees in History and Political Science.
