Kathleen Phillips

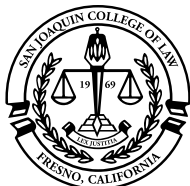

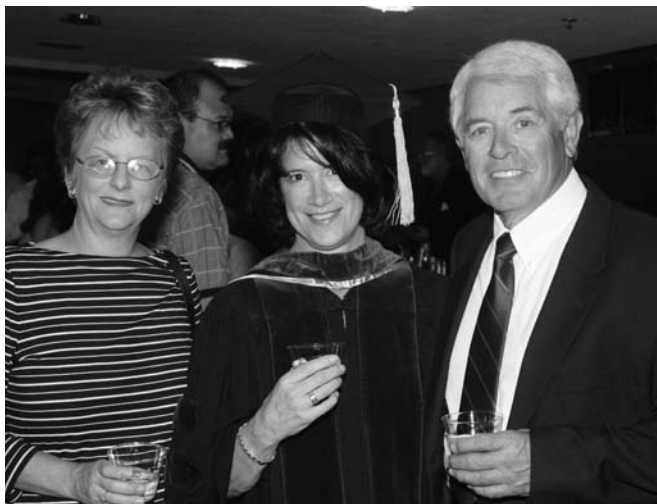

1978 Phillip Cline

Phil is the Tulare County District Attorney, an office to which he has been elected four times. In 2006 he was re-elected by the highest margin in the history of Tulare County for a contested race.

Phil has been married to Marcia for 37 years. Their son, Jarrett, is a deputy district attorney (and SJCL graduate) for Fresno County. Their daughter is a teacher. Their granddaughter is the prettiest and smartest little girl in the history of Western Civilization.

Phil has won numerous awards over the years: Exeter Union High School Alumnus of the Year; Farm Bureau Special Recognition for creation of the Rural Crime Program; Farm Bureau Special Recognition for creation of the ACTION Program; Latino Peace Officers award for support of Scholarship Program HEART; MADD (Mothers against Drunk Drivers) recognition; Governor's recognition for Statutory Rape/Teenage Pregnancy Prevention program; Patriotic Employer from The National Committee for Employer Support of the Guard and Reserve; Ruthie D. Gale Excellence in Achievement Award from Celebrate the Child Within, Inc.

Phil loves to golf, read, spend time with his granddaughter and cruise the coastline in his 50th anniversary Corvette -- breaking the law does have its thrills.

Phil is a member of the Rotary Club; HEART after school reading and

enrichment program; the Library Foundation; Visalia Sons of Italy. At various times he has served on boards and/or raised funds for CASA, Library Foundation, HEART, and others.

Phil also created a unique program called the Direct Community Benefit Program, which encourages corporate violators of unfair business practice statutes to contribute to worthy local non-profits, as part of their settlement of cases brought by the District Attorney's Office. It has resulted in hundreds of thousands of dollars being directed into reading, library, senior citizen, food for the hungry and children's programs, as well as Family Services and Rape Crisis.

Phil is the Tulare County Bar Association, Past President; California District Attorney's Association, Board of Directors; Tulare County Police Chief's Association. He is the only District Attorney ever elected president, and has served three terms. Currently Phil serves as Secretary /Treasurer. He has served on the Juvenile Justice Commission; Latino Peace Officers Association - one of only three honorary members in history of organization; Legislative Committee, California District Attorney's Association; Public Assistance Fraud Committee, Chairman, California District Attorney's Association; Tulare-Kings County Basic Police Academy, Advisory Board, College of Sequoias.

Phil's special SJCL memories include the study group sessions with Tim Magill and Steve Sefton and then the family get togethers. They were so young then, with little kids and work-

ing so hard at their real jobs during the day so they could get to what they loved at night -- law school. He also has fond memories of Dean Eymann's Torts class and Dean Loomis' Contracts class. It's where Phil fell in love with the law. Lastly, he remembers eating at Me and Ed's Pizza by himself before every exam. It was a quiet ritual from which he never deviated.

Norma Jean Crane

Norma consulted on and investigated discrimination cases during law school. This continued to be her passion throughout her career. Norma moved from Fresno to Los Angeles just after graduation to join the Department of Fair Employment and Housing. There she prosecuted civil rights cases for the EEOC for 8 years. Then she took a leave and moved back to Fresno to open a general law practice with Kathy Kesselman and Keith Lusk. Norma was shocked by the attitude of their clients in Fresno; the clients did not want to pay for services.

Norma stayed in Fresno for about a year, then was offered an opportunity to rejoin the Department, so she moved back to Los Angeles. In 1988, the governor appointed Norma to be the Deputy Director of the Office of Administrative Hearings, so she had to travel to Sacramento weekly. She supervised administrative hearings under the Business and Professions Code statewide. These cases involved discrimination based on race, age, ethnicity, physical handicap and sex. One of her favorite cases was where the horse racing industry was charged with alleged use of enhancement drugs. She learned a lot about the industry and was struck by the amount of regulation that industry had bestowed upon itself.

Traveling to meetings got very difficult after the office opened an additional court in San Diego for Norma to oversee. So in 1991, while she was living in Pasadena she was offered a Workers' Compensation judgeship. She enjoyed

that work immensely. In 1996 while living in Monrovia Norma fell coming out of her chambers. Norma has been disabled since that time. Currently she lives in Monrovia with 24-hour care.

Norma has a grown son and two grandchildren. Her granddaughter lives in Fresno and her grandson lives in Las Vegas.

Norma has received numerous awards and accolades for the legal work she has done over the last 30 years. One of her fondest memories while at SJCL was when she wrote a “very toned down” article for the *Dicta*. She begged her classmates to think about fairness and the equality of women. (she was an ardent Women’s Rights Advocate). The paper declined to print her article until Keith Lusk stepped in and as she states “raised a little hell”. It got published. Her fondness for her classmates has not diminished over the years as she cherishes those memories.

Glenn Gates

Glenn has been generally self-employed since he began practicing law. He was in a few partnerships over the years and found he preferred working for himself. He had some very intelligent, hardworking partners from whom he learned a great deal. His practice involves general business litigation, family law and bankruptcy.

Glenn has three children and a beautiful granddaughter. His oldest daughter, Kristen, graduated from SJCL last month and is studying for the bar. His daughter, Maren, has a Masters degree and teaches fourth grade in Virginia where she lives with her husband, Nick. As difficult as it was, he somehow made it. Glenn realizes it was a fine legal education. He will always be thankful to Hon. Dan Eymann, Hon. Oliver Wanger and Mr. John Loomis for admitting him.

Sweet* (2003) 30 Cal. App. 4th 1232.

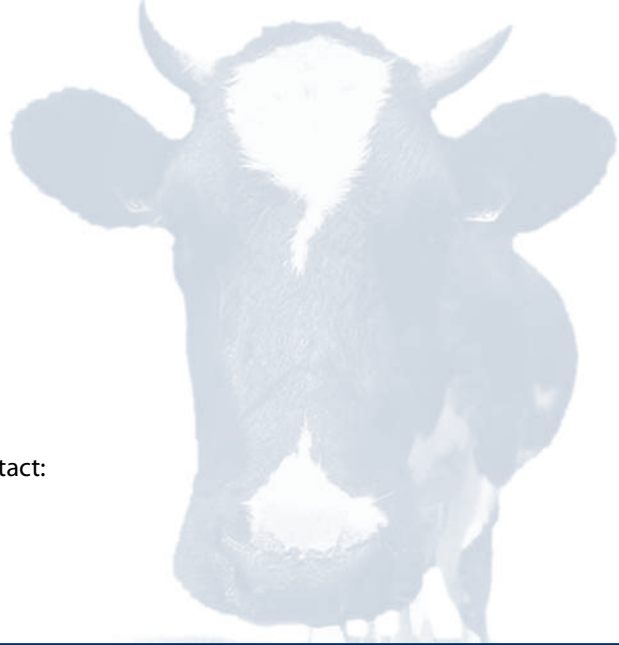
