CONGRATULATIONS!!! After ten years of work, SJCL has achieved WASC accreditation. All of you who have devoted so much time to the school over those years are entitled to be proud. WASC accreditation recognizes those efforts and establishes SJCL as a full-fledged member of the higher education community.

Part of being a WASC accredited institution is a commitment to constantly strive for improvement. Accordingly, it is appropriate to look at the recommendations made by the WASC monitoring team. Two recommendations were foremost.

First, SJCL must relocate to a more adequate and appropriate physical facility. The Shields building is insufficient for the current student population. Although SJCL does not expect a larger student population, there will be growth in activity and academic endeavors. Library development is hindered by lack of space. Office space is inadequate for faculty and an efficient administration. Moreover, SJCL deserves a home that reflects its serious educational purpose.

The efforts to find a new building are continuing within SJCL's stringent financial parameters. I expect a site will be resolved

upon by the end of this fiscal year in July. This will be a major move for the school and we hope you will be able to assist in a fundraising effort to make it possible.

Second, although WAŚC recognized the significant commitment of the adjunct faculty, the award of accreditation was conditioned upon SJCL continuing to expand its full-time faculty to achieve a good balance. Full and adjunct faculty make different and important contributions

to the operation of the school, but with SJCL's growth, there are so many tasks to be performed and additional faculty are essential. The sixth full-time faculty position is slated to be filled this summer. As part of this recommendation, WASC advised that SJCL should closely monitor the workloads of full-time faculty to ensure they are not overextended and their conditions of employment appropriate.

Third, WASC recommended that SJCL better formalize its planning processes, culminating in a formal five-year plan. In particular, WASC recommended that the faculty of all three programs be more involved in this planning. This process will begin with the annual retreat in May.

Fourth, SJCL will be forced to move to more sophisticated accounting systems as a WASC institution. Moreover, if Congress adopts direct lending for financial aid, SJCL will have to hire a new staff person simply to handle the additional paperwork. Direct lending means that loans will be made directly to students through the school, rather than through a bank under the current system. This will save money

for the federal government but put significant new burdens on small institutions like SJCL. If direct lending is adopted, which seems likely, tuition will rise at SJCL and at most other institutions, solely to deal with this new responsibility.

WASC also made numerous other recommendations. They suggested that the Board be enlarged to enhance fundraising for the school. They recommended that SJCL proceed with plans to survey stu-

dents, alumni and employers to measure the effectiveness of SJCL educational programs. They felt the school should more emphatically articulate publicly its growing regional importance. WASC also suggested SJCL rewrite its mission statement to better reflect the school's clear commitment to diversity.

There is always more work to do, plus the most important work

of constantly re-examining the academic program to keep it current and of highest quality. On that front, WASC complimented the Law Review, the school's commitment to writing training, and the ability of the faculty. In fact, one point was very gratifying. So often, SJCL is wrongly accused of only teaching people to pass the Bar exam. (Whatever that means). The WASC team had this same concern but reported that such did not seem to be the case. So congratulations! You all accomplished what many thought to be impossible.



Annual Fund Commitment Assures Future of SJCL

The 1993 Annual Fund is underway, and we look forward to your participation. Letters have recently been mailed inviting you to take a few moments to consider your contribution this year.

The Annual Fund is the primary source for increasing the Endowment Fund. A strong endowment helps assure the future of the Law School and demonstrates clear support for the goals of SJCL. These goals include providing quality, affordable legal education for individuals in the Central Valley while matching the needs of the legal community with qualified law and paralegal graduates. Achieving this goal depends on the support of each alumnus, student, faculty and friend of the college.

The Endowment Fund was created in 1985 by individual and private contributions. In 1992, some 61 individual donations generated more than \$15,000 to this fund, and over the years, the fund has grown to \$230,000. Our goal for this year is to substantially increase the number of donors and the amount generated. We need each of you to make that happen!

One of the criteria for our WASC accreditation was a demonstrated level of financial support by alumni and community members. Your efforts over the years were important factors in the decision by the commission.

As we plan for our future, continued financial support will become even more critical. Costs of operation rise with economic changes and our goal is to keep tuition affordable while improving our program. While the Endowment is not used for annual operations, its continuing growth means a more stable and predictable base for the law school – one on which we can build for the future.

WASC accreditation is an important milestone for SJCL. We anticipate 62 graduates in May. The prospects of a new building and campus appear ever closer on the horizon. We plan to hire a new full time faculty member for Fall '93, and applications for the fall term arrived earlier than ever for our selection of the approximately 100 candidates who will become the 1993 entering class.

Taxing Times And A Change Of Venue: On The Road With The SJCL National Moot Court Team

F. Lee Bailey Moot Court Coordinator: "...so we anticipate no difficulty with SJCL attending the F. Lee Bailey Criminal and Constitutional Law National Moot Court Competition".

F. Lee Bailey Moot Court Coordinator ten days later: "Sorry to inform you that two schools have protested your entry on the basis that the competition rules require ABA accreditation...".

It is my understanding that the true rationale behind these protests was rooted in SJCL's formidable record in national competition rather than as a genuine plea to preserve the integrity of the competition itself.

Although I do not imply that SJCL necessarily strikes fear in the hearts of our competitors, it is common knowledge in national moot court circles that SJCL's entrants are far from easy pickings.

Subsequent to our banishment from the Bailey, SJCL Moot Court Coach Kevin O'Casey informed me that the only remaining national tournament was the National Tax Moot Court in St. Petersburg, Florida. Faced with the difficult decision of going through the Tax competition or staying home, my partner Carla Bourne and I ultimately learned together that, as adaptability is the key to survival, teamwork is the key to success. We decided to play the hand that was dealt.

Given the subject matter of the competition and our late entry, I had not logically expected that our team would actually have a chance to prevail in a tax law contest. As it turned out, we had somewhat more than a chance.

Our opponents were gunning for SJCL from the outset. Carla and I were both amused and surprised upon noticing that we were being "scouted" by other teams, whose personnel sat quietly with note pads at the ready to transcribe our arguments and strategy. While some other teams were accompanied by entourages including coaches, coordinators, researchers, family members, and possibly psychics and other spiritual advisors, SJCL's less weighty contingent (consisting of Kevin, Carla and myself) proved once again that the size or budget of a school is less crucial than the determination of its students and the quality of its coaches.

Our team was put to the test from the outset, as our first opponents were

Southwestern University, the eventual winner of the tournament, and Villanova University, the eventual fourth-place finisher. Once we defeated both of their teams on the first day, Carla and I began to realize that a team award for SJCL was wholly attainable. Then, on day two, we advanced to the quarter-finals, and then the semifinals as a result of defeating Syracuse University. At this point, we were scheduled to face Southwestern once again for the right to compete in the final round.

Simply stated, this round was an all-out fight. Neither team committed a noticeable error nor conceded even one point of law

or fact. Nerves were tested to the breaking point when the judges came out after deliberating for ten minutes and asked us to wait. They could not reach a decision in the ordinary amount of time because the round was simply too tight to call—an occurrence which had never taken place in the history of the competition. Ten minutes later, the doors flung open and our team met its fate by a measly but significant fraction of a point.

Stunned but unbowed, our team was scheduled to argue against Villanova again in

the consolation round for third place. Frankly, it probably would not have mattered who we faced, because Carla and I were determined to leave town with a win or else.

The consolation round proved to be a highlight of our journey. We argued before Judges Irene Scott and David Laro of the U.S. Tax Court, and Judge Michael Kanne of the Seventh Circuit. Converting our obvious disappointment into more positive energy, we secured the third place team award. Further honors included an award for runner-up brief and an individual runner-up oralist award for Carla.

Overall, our team compiled a 4-1 record at the competition. Out of sixteen teams representing virtually every region of the U.S., SJCL was one of only two entrants to capture team, brief, and individual awards. Final team results: Southwestern 1st, Fordham 2nd, SJCL 3rd, Villanova 4th.

Our team wishes to extend sincere thanks to Jan Pearson and the entire Administration for their encouragement. Further appreciation is extended to Sarah Schmidt for her support, and boundless faith. We thank Joyce Morodomi and Diane Johnson for their assistance, Patti Williams and Marlene Hubbell (former Tax Court Champions) for their time and advice, and Paul Fairless for his voluntary participation as computer consultant.

As for Kevin, our coach and one-person entourage, one can only comment that it is the high caliber of coaching as embodied in his efforts which has helped to elevate SJCL beyond its size in terms of the ability to compete consistently at the highest levels. We were fortunate indeed to work with him.

No account of this experience would be complete without a heartfelt expression of gratitude to my partner Carla Bourne for her cooperation and commitment. Everyone connected with the program wishes Carla all of the success, respect, and happiness that she has justly earned through her hard work and obvious talent.

As a final note, SJCL is endeavoring to be invited to the Bailey competition next year as a representative of non-ABA schools, and I intend to participate. If what goes around truly comes around in this life, SJCL will prevail on another day against the very same ABA teams that protested our entry this year. We'll be back...



It was also at this time that the concept of the "legal assistant" was just beginning.

After she finished school, Suzanne began working for the General Motors Acceptance Corporation, serving in the accounting department. She didn't do much typing, but she did handle contracts, credit ratings and clients.

During this time, Suzanne continued working toward a Bachelor's degree, got married and had a baby. After the arrival of her son, she worked part-time for a short period but then decided to become a full-time mother.
