


1999 SJCL Paralegal Graduation

SJCL receives WASC reaccreditation

At its February 24, 1999 meeting in San Francisco, the Western Association of Schools and Colleges (WASC) reaffirmed the regional accreditation of San Joaquin College of Law. Accreditation was reaffirmed for ten years. The Western Association of Schools and Colleges is the accrediting entity for all major colleges and universities in California and Hawaii.

SJCL was first accredited by WASC in 1993 for a period of five years. Regional accreditation recognizes an institution as a serious educational institution. Regional accreditation is necessary for students to be eligible for Federal Financial Aid. Regional accreditation involves a year of self-study by the institution and evaluation by its peers, an invaluable process for the development of the institution.

San Joaquin College of Law is the only state and regionally accredited law school in the Central San Joaquin Valley. Founded in 1969, SJCL has contributed greatly to the legal profession in the Fresno area. In fact, 25.5% of all attorneys practicing in the Fresno area are graduates of SJCL, including 42% of female attorneys and 28.5% of minority lawyers.

Law Alumni Profiles

Throughout 1999, Inter Alia, will highlight the lives of the 1979 and 1989 SJCL graduates.

HON. JOSE BANUELOS CLASS OF 1979

After completing law school, Jose went to work for the California Department of Social Services in the Licensing Unit representing the State in administrative hearings regarding day care centers, board and care facilities, and the like. In 1992, he became an Administrative Law Judge doing fair hearings on issues of AFDC and general assistance. He is currently the Presiding Judge in the Fresno office consisting of five administrative law judges.

Jose and his wife, Carol, have two sons and twin daughters. Matthew, the oldest, has a teaching credential from Fresno Pacific University and now teaches in Dixon. Heather is a second-year student at USC law school. Holly is pursuing a Masters Degree in classical music at the Cincinnati Conservatory of Music. Joel is completing his B.A. in psychology at UC Berkeley and plans to be a physical therapist. Carol works as a Coordinator of Outpatient Care at Valley Children's Hospital.

Jose does three things for fun—read, play golf, and ride motorcycles. He and a group of buddies undertake a one-week ride each winter and a two-to-three week ride each summer.

Jose remembers his first law school study group. His entering class started, as he recalls, with 115-125 people, but only 26 advanced to the second year. All of his study group passed the first year and then passed the Bar on their first attempt.

RANDY LONG CLASS OF 1989

Randy worked with Chuck Magill at Smurr, Henry & Gelegan for approximately a year and a half after graduating from law school. In April 1991, Randy opened his own practice in Reedley, emphasizing estate planning and business planning. Randy is also a Certified Financial Planner and a partner in an investment advisor business. His practice is extremely busy but Randy reports that he absolutely loves what he does, especially since he is rarely in court so he seldom wears a tie.

Randy and his wife, Lydia, have four children (12,9, 6, and 4), whom Lydia has been home schooling. They love to snow ski and have a cabin at Hume Lake and another on the coast. The two oldest children—the girls—are active in Club Volleyball. Randy is a Foundation Board Member for the Mennonite Brethren Church and a trustee of the U.S. Mennonite Brethren Conference. He is counsel for the Hartland Christian Camp and Immanuel High School.

In hindsight, Randy says law school taught him to think like a lawyer and to recognize issues. He has fond memories of a lot of hard work done with his study group.

CHARLES MAGILL CLASS OF 1989

Chuck worked as an associate with Smurr, Henry & Gelegan, then opened a sole practice focusing almost exclusively on criminal law. The high points of that practice for

Chuck have been representing clients who were profoundly innocent and being able to prove it. He is discouraged by recent changes in the direction of criminal law, emphasizing incarceration even for less violent crimes and ignoring rehabilitation, as well as the continuing loss of individual civil rights.

Chuck has joint custody of his two boys, who are 6 and 12. Chuck describes them as the joy of his life. He spends endless hours with them at soccer and baseball games.

Chuck remembers law school as a trying and difficult time, but time well spent. In fact, he even misses the intellectual challenge.

JANET MAUS CLASS OF 1989

Upon graduation, Janet worked briefly for Perez, Makasian & Williams were she had served as a law clerk during law school. Janet then worked with Georgeson & Belardinelli. In 1991, she joined the Law Offices of Edward B. Chatoian specializing in plaintiff's personal injury work and worker's compensation. In March 1998 she joined Yohman, Parker, Kern & Nard, working in the Subrogation Department. Janet files complaints or intervenes in existing actions on behalf of workers compensation carriers in an effort to recoup funds the carriers have paid in benefits to victims. 
SJCL Moot Court Team in Traynor Moot Court Competition

SJCL's first round competitors were from Trinity College of the Law. Jon Conklin reported that although their competitors were well prepared and did a fine job, they were no match for JoAnn and Stefanie, who were both well prepared, poised, and very professional in their presentation.

The team and its fearless leaders were very pleased, but not surprised, to learn that they had advanced to the semi-final round that was to be held later that day.
