

### **MCLE** Requirement Judgment


The California Supreme Court in *Warden* v. *State Bar*; decided August 26, 1999, upheld the constitutionality of the state's MCLE requirements. Reversing the appellate court's finding of unconstitutionality based upon an equal protection challenge to the list of exempted members of the State Bar, the California Supreme Court found the exemptions rationally related to the purposes of the statute. Therefore,

while retired judges, officers and elected officials of the State of California and full-time law professors at accredited law schools remain exempt from MCLE, all other active members of the State Bar must continue to satisfy MCLE requirements.

### www.sjcl.org is a hit!



# Law Alumni Profiles

Throughout 1999, Inter Alia, will highlight the lives of the 1979 and 1989 SJCL graduates.

### HON. ERIC HELGESEN CLASS OF 1979
