ALUMNI and FRIENDS of the COLLEGE: CREATE A SCHOLARSHIP

Alumni, remember when you were a poor, starving, overworked law student, sacrificing time with family and friends to pursue your law degree? Wouldn't it have been great if someone recognized your hard work (and maybe given you a little money)?

Each year at the Spring Banquet we honor the achievements of various students and recognize their struggles and sacrifices. Currently, the law school administers approximately 25 scholarships, totalling over \$30,000 per year. Scholarship amounts range from \$250 to \$3000 per recipient. These scholarships are made possible through the continuing generosity of alumni and others concerned about the students at San Joaquin College of Law and the legal community.

Some scholarships focus on academic achievement, community service, leadership or financial need. Others, seek to identify and help students particularly interested in practicing in such areas as trial advocacy, family law or criminal law. Finally, some scholarships are directed toward those for whom attending law school presents a special challenge—students who must work full time in addition to going to law school, single parents or those who have otherwise worked through adversity.

Law Alumni Profiles

Throughout 1999, Inter Alia, will highlight the lives of the 1989 SJCL graduates.

MICHAEL GOLDRING CLASS OF 1989

Michael has worked with Baker, Manock & Jensen since passing the California bar examination in December 1989. Initially his practice focused upon real estate transactions, but seven years ago, his interest turned to the health field. Michael is currently Chair of BMJ's Health Care Industry Group. He works with every type of provider on every type of transactions. He is currently working with a group of providers considering suit against the federal government for inadequate levels of Medicare reimbursement in the Central Valley. He serves as health care counsel to consultants and other law firms locally and nationally, and frequently lectures on health care issues.

Michael currently serves as President of Exceptional Parents Unlimited whose mission is to support families facing extraordinary medical, developmental, and parenting challenges. He also serves on the Fairness 2000 Coalition lobbying for national Medicare reform. He is Chairperson of Valley Children's Hospital's Parent Advisory Committee and works with the San Joaquin Valley Consortium of Health Care Providers and Commercial Law Affiliates.

Michael and his wife, Kimberly, have three daughters—Jocelyn (12), Alexis (8), and Rachael (7). He says he doesn't have any time for fun buthe does play ice hockey and chauffeur his girls around. When asked about his memories of law school, Michael immediately said that he remembers his study group meetings and the overwhelming amount of food provided by his study partners, Jim Petrucelli and Bud Ellis.

CASEY OLIVER CLASS OF 1989

For roughly the first five years after graduation, Casey worked in insurance defense for Silveira, Mattos & Lewis in Merced. In her first trial, against counsel for whom she had worked as a law clerk during law school, the insurance company authorized her to admit liability and try damages issues, but the jury returned with a zero damages award. This gave Casey a real taste of the thrill of trial work.

In August 1994, Casey opened her own practice in Merced where she specializes in family law and personal injury work. She represents juveniles and conservatees by court appointment, including occasional homicide cases. She recently settled a PI case with only \$17,000 in medical damages for \$250,000.

Casey adores running her own practice because it gives her the flexibility to do things with her kids. Casey has three children—the oldest just started studies at Merced College, the middle child is in the third grade, and the youngest is in kindergarten. A typical day for Casey may begin making clay ornaments in kindergarten and end sitting as Judge Pro Tem.

Casey helped establish a pro bono family law clinic in Merced about three years ago. Family law attorneys meet each week to assist a group of potential petitioners in completing their forms and representing themselves in obtaining a dissolution.

Casey loves to scuba dive and ride her motorcycles and horses. Until recently, when she broke her collarbone in a fall from a horse, she was also taking karate lessons. Casey also loves to travel with her children. This last year they undertook one excursion to Colorado, Mesa Verde and the Grand Canyon and another to Washington and western Canada. On the Canadian trip, one daughter had custody of her class pet - a tarantula - so there are pictures of the tarantula at various U.S. and Canadian monuments!!!

As to law school, Casey remembers being determined to get the highest grade in at least one class. Throughout high school she had always been the top grade getter. She says she worked so hard in law school, and finally got the top grade in Family Law. In contrast, she remembers being in tears over grades in Doug Noll's Remedies class. She feels she got a

The pass rate statewide was the lowest pass rate in 12 years. Nonetheless, 46.5 percent of SJCL first time takers passed, as compared to an average of 33.3 percent for graduates of all state-accredited law schools.

CHELA Scholarship Winners

San Joaquin College of Law students Geoff Adalian, Rod Kodman and Michelle Pepper were awarded \$1,000 Chela Financial Scholarships. Chela Financial is a nonprofit corporation that provides financial assistance to students pursing a higher education. Since its founding in 1984, Chela Financial has made nearly \$3 billion available for higher education to over 780,000 parent and student borrowers. After receiving hundreds of nominations from schools throughout

eight states in the Western Region, the Chela Scholarship Committee used three criteria in reviewing candidates: level of indebtedness, perseverance, and school/community involvement. In addition, students who excelled academically while overcoming extreme hardship earned special consideration. San Joaquin College of Law is thrilled that three of its students each received one of the 150 scholarships available.


RICK HEATTER CLASS OF 1989
