As San Joaquin College of Law reaches the respectable age of 30, it's time to party.

hat could be better than a reunion of all the students and all the faculty in the school's history?

Founded in 1970 by Judge Dan Eymann, Oliver Wanger and John Loomis to provide a local site for quality legal education, SJCL has made a difference in the lives of hundreds of Valley residents and changed the face of the legal profession in the Central Valley. Alumni of the Law, Paralegal and Tax programs now number 1,287. Over a quarter of the bar in the Fresno Metropolitan area graduated from SJCL. Almost one half of the women practicing law in the Fresno area received their training at SJCL. Almost a third of the minority bar earned their degrees from SJCL. Of the current student body, over two-thirds were born and raised in the Central Valley.

Moreover, numerous members of the bar and bench have given of their time, knowledge and experience to train aspiring attorneys, paralegals and tax professionals. Over 150 local attorneys and judges have taught at San Joaquin College of Law.

On Saturday, September 16th we want to bring everyone back together. We've begun contacting members from each graduating class to help organize the festivities. Each class will have its own area to display memorabilia, pictures, whatever. (Well—if someone wants to bring the dumpster from Shields, there might be a

The Dean hits 15 years and 30 cats

SJCL recognizes the dedication of Jan Pearson

J an Pearson began teaching at the law school in 1982 as an adjunct professor, teaching Debtor-Creditor Law. A plaque with a very large screw hangs on her wall—a gift from her first class. She taught her first Torts class in the 1982-1983 academic year. She has been the sole Torts' instructor at San Joaquin College of Law since that time. Over 590 attorneys learned Torts from Jan.

In 1983 she became Associate Dean, while Carol Sellers Herbert served as Dean. In June of 1985 she began her official tenure as Dean of San Joaquin College of Law. For the last 15 years — half of the school's existence she has shepherded the law school in its quest to provide a quality legal



education to people desiring to enter the legal field and to be a resource to the local community.

In 1992 she received the Justice Pauline Davis Hanson award from the Fresno County Women's Lawyers. She was recognized with the Liberty Bell Award in 1993 and a Finalist for YWCA / Fresno Bee Professional Woman of the Year in October 1990. Jan has also been voted SJCL Teacher of the Year in 1986 and 1996.

While Jan estimates her cat population has gone from 4 to 30 in her years at San Joaquin College of Law, some things stay the same. Frenzy the cat still rules the roost at Jan's house. At 17 years old he accepts homage from all the other cats each day, as well as receiving a very special diet of raw chicken from Jan and Jackson.

SJCL participates in "Rails to Trails"

"Rails to Trails" was a huge success with almost 3000 volunteers participating.

n May 6, 2000 Tree Fresno coordinated almost 3,000 volunteers in planting almost 5,000 15-gallon deciduous and evergreen trees in three hours, making this the nation's largest documented single-day planting. Planting these trees transformed the former railroad tracks into tree lined trails which provide recreation paths for residents. The trail starts in southern Clovis, moves through North East Fresno, and ends in the new Riverpark shopping center.

Although many practice resources are available online, only about 25% of the resources needed by a research law library are currently computer accessible. Without the Garabedian gift, SJCL would not have been able to properly house this old collection.






