SJCL students take top honors overall

or the second year in a row, ◀ students from San Joaquin College of Law received the top honors in the state wide Roger J. Traynor Moot Court Competition. This year's participants were Ed Johnson, Greg Norys and Lillian Weiland. Their legal brief was awarded the "California Academy of Appellate Lawyers Award for Brief Writing." Based on scores from their oral arguments and the written brief, the students were awarded the "Bernard E. Witkin Award for Excellence in Legal Advocacy." It recognizes the best overall advocate team in the

competition. The students were awarded

a \$1200 scholarship by the California Academy of Appellate Lawyers, which sponsored the competition, along with the Witkin Legal Institute.

The Traynor Moot Court Competition is a nationally recognized appellate moot court competition held annually in California. This year seventeen California law schools participated including University of California, Berkeley (Boalt Hall), University of

California, Los Angeles, School of Law (UCLA), University of California, Davis, School of Law, and Hastings College of the Law. The team was coached by Assistant United States Attorneys Jonathan B. Conklin and Stanley A. Boone, adjunct professors for SJCL. They said "These students competed against the best in the state and took top honors overall. That accomplishment, and what it says about the high quality education provided to the students at San Joaquin College of Law, should be

recognized by this community and throughout the State."

First year law student on A&E's American Justice

First year student Michael Elder was inspired to attend law school because of his experience serving as a juror in the Dana Ewell criminal prosecution in Fresno. It got



him on TV, as well. A&E's show, American Justice, did a special on the jurors in the case and Mike was one of the jurors featured. The show aired in January 2002. Now American Justice has taped a two-hour Tenth Anniversary special

which will air this fall, showing the long-term impact of the trial on selected jurors' lives.

American Justice followed Mike with a TV camera for a day, starting early in the morning and ending in his firstyear Contracts class taught by Professor Larry Artenian.

Mike explains that "As a member of the Ewell jury I became aware of how our jury system needs improvement." In a trial that lasted seven months, Mike realized the attorneys who were advocates for the jurors (i.e. asking for a recess when they noticed the jurors were tired) got more sympathy from those jurors and had a major effect on the jurors' during their deliberations.

One of the major changes Mike would like to make is in the amount of

information jurors are allowed. Mike points out that in Arizona, unlike California, jurors are allowed to talk to each other and receive more information about the trial.

Mike believes his

business management experience with Pacific Bell and his knowledge of how to advocate for jurors will give him an advantage in jury trials. "Jurors need information presented in a very organized manner that gives them just what they need-too much informa-



tion and they become overwhelmed, too little and you lose your case," he says. He also points out that since attorneys are seldom allowed to sit on a jury, he will have the advantage of having lived the juror's experience.
