# 1975

#### William L. Cowin

It's been 30 years since San Joaquin College of Law gave birth to its greatest class, according to William Cowin. He grew very fond of his classmates and has great memories of law school.

He remembers the Sunday trips Jim Wasson, Ernie Kinney, Larry Donaldson, Ima Jean Harvey and he made to San Francisco in his gray Sport Fury to take the SACK writing class. One Sunday, they were late leaving Fresno because Wasson overslept, and were stopped by a CHP officer on I-5 who alleged they were going 120 mph. Wasson, a CHP officer at the time, talked his way out of a ticket. When the officer left, Wasson said, "Gun it, Cowin, we have to make up for the time we lost getting stopped!" So back on the road at ??? mph they went. They passed Larry Donaldson in Livermore. Larry later said he had increased his speed to 100 mph when he spotted them in his rear view mirror, but all he saw was a gray streak when they passed him. They made it from Fresno to San Francisco in two hours flat. Ima Jean asked them never to tell anyone his story. (Sorry, Ima Jean.)

The bar exam was also an experience. Donaldson and Cowin had to share a hotel room with one small bed. (It's quite a story and, yes, Larry was a gentleman!) He learned he passed the Bar Exam when he arrived home one evening and Tom Campagne had left a big note on the front door that simply said, "You passed." Bill was initially puzzled by the note, because Tom's "a" in passed looked like an "i". Bill and his family went to Tom's mother's home. Jim Wasson was also there and the three of them ate the entire cherry pie Tom's mother had baked for the occasion.

Immediately after being sworn in as an attorney, William wrote his name on a piece of cardboard with a crayon, tacked the "name plate" on his first office door in the Security Bank Building, and commenced private law practice. In 1978, Ernie Kinney, Jack Johnson, Chuck "Bill" Brewer (Class of '76) and William, along with Stan Tibbs, formed the infamous "Cowin, Johnson, Brewer, Tibbs and Kinney" law firm. It was a great association and quite a mix of personalities. Jim Wasson was to have been included in the firm, but he got cold feet (or perhaps smart - we'll never know). The firm dwindled to "Cowin, Johnson and Brewer" when Tibbs passed away and Kinney went to Hawaii. Then it became "Cowin and Johnson" when Chuck Brewer left for the City Attorney's Office. In 1986, William formed "Cowin, Opel and Hrdlicka, which later became "Cowin and Hrdlicka", with Steve Hrdlicka. For the past ten years, William has been a sole practitioner, with his daughter-in-law, Cathy, as associate counsel. He has had the same telephone number for 27 years, which is probably a record in the Fresno County Bar.

William holds the (unofficial) record for the most Pro Bono work performed by any attorney. Representing the American Ag Movement and working to get the Farm Credit Acts of 1985 and 1987 passed were his most rewarding achievements. Thousands of farms were saved from foreclosure due to these acts. He made many trips to Washington D.C. for three years, meeting with congressmen, senators and various agency staff in an effort to save family farmers. He strongly believes the long term interest of this nation is best served if a majority of the farmland is owned and operated by family farmers. His best Washington

D.C. record was set when he visited 42 senators and congressmen in their individual offices in four days. He had condensed his "pitch" to a 10 minute delivery, which some of my collegues may find incredulous.

During the early years of his practice, William formed the California Agricultural Museum, with other community members. More recently, his family, particularly their son, David, was very involved with Measure Z (Save the Zoo). David was ultimately the first person appointed to the new Zoo Board after Measure Z was passed.

William met his wife, Ann, the light of his life, when they were 17 years old and in their first year of college. They have been married 43 years. They have two sons and eight grandchildren. They are fortunate that their family all live nearby, so they can enjoy being with them. They owned and operated a 25,000 bird poultry ranch for 10 years, including the years he was attending law school. They farm together, she manages his law office, and she's his best real estate agent. They have lived on their ranch near Kingsburg since 1978. It is said that a successful man should have three things in his life: a good woman, a good pickup and a good dog. William has all three, so he considers himself a success.

#### **Larry Donaldson**

Larry first went to work for Richard Isham in Visalia. He worked there for 4 years, then open his own private practice doing general civil, child advocacy, and criminal defense. He then joined the Kings County District Attorney's office as Assistant District Attorney for 4 more years. After running for District Attorney there and coming up a few votes short, he went to the DA's office in Fresno where he prosecuted sex offenders for one and one half years. Larry then worked as the Legal Advisor for the Fresno Police Department for 16 years as a Senior Deputy City Attorney. He is currently a partner with a great friend, Martin

Koczanowicz, at Koczanowicz & Donaldson in Oakhurst. They do general, property, municipal law, personal injury and wills & trusts. Larry spends some time in Grover City, as a back up to Martin who is the City Attorney for Grover Beach, which he enjoys.

Larry has been married to Marie for 29 years; she is a first grade school teacher in Riverdale. They have raised three children – Debra, a grant writer for a health care consortium in Visalia, David, a motorcycle officer with the Fresno Police Department, and Amy, a physical therapist assistant in Paradise. All their children are married. Larry and Marie enjoy two grandchildren, Christopher and Stephanie.

Larry is a member of the Oakhurst Noon Rotary and the Eastern Madera County Bar Association, and participates in the League of Cities with his work in Grover City. In his spare time enjoys playing golf.

Larry, too, has fond memories of his law school days. The reason he had to share a room with Bill Cowen was that his ex-wife had taken his room. That forced Larry to rely on the kindness of Bill to make it through the exam. Those trying days were only tolerable due to the friendships of Ernie Kinney, Jim Wasson and Bill Cowin. Larry recalled being at his in-laws for Thanksgiving when Ernie and Jim called to tell him he passed the Bar. Larry knew in his heart he had done so poorly that he hung up on them. Ernie and Jim called again, so Larry hung up again, this time with naughty words to his friend. Ernie and Jim were persistent and called back again, determined to convince him they had seen it in print. Larry did not believe them until he received the official notice several days latter. Then they all celebrated. To this day Larry considers Ernie is his favorite "crazy person" and the best damn criminal defense attorney in this state and beyond.
