Congratulations to the Honorable Gary S. Austin (Law '76) and Michael G. Marderosian (Law '77) on their induction into the SJCL Hall of Fame.

### Honorable Gary S. Austin

was the Student Body Association President at SJCLin 1976. After graduation he first worked as a law clerk for the District Court for the Eastern District of California and then as Deputy District Attorney. He became a Municipal Court judge in 1986. In 1988, he joined the Superior Court, where he presided over criminal cases, including death penalty cases, served as Presiding Judge of the Juvenile Division and has presided over civil and family law matters. He currently serves as a United States Magistrate Judge for the Eastern District of California, following almost twenty years

in the Fresno County Municipal and Superior Courts.

Gary has a new bride this year, Kim, who works for the Administrative Office of the State Courts. Gary's son, Brice, is a splendid student and a fabulous athlete in high school and Gary's dedication to family is unparalleled.

## A Holiday Message from the Dean



As 2008 draws to a close, I am reminded of the major events and accomplishments of SJCL's year. A number of things stand out for me.

The faculty have made a series of academic decisions that have positively impacted SJ-CL's academic program and supported greater student success. An expanded pre-enrollment orientation offers entering students great insight into the study skills needed to succeed in law school. Two new classes - Analytical Process in the second year and Legal Process in the graduating year – focus specifically on the thought process involved in all legal reasoning. In part because of these and other academic initiatives, SJCL is seeing a steadily improving first-time pass rate and a cumulative pass rate in excess of 85% that has always been impressive.

A major effort in 2008 was the WASC (Western Association of Schools and Colleges) Capacity and Preparatory Review, the first of a two-step, multiyear process whereby SJCL seeks to renew its regional accreditation. This effort entailed a massive study of SJCL's academic program and operations followed by a site visit by five educators from other WASC institutions. As always, their insights and recommendations will help SJCL to become a stronger institution.

It is impossible to emphasize the value of the work of the staff and faculty

or to thank and acknowledge them enough. Everyone knows faculty teach classes and grade papers, but they also participate in curriculum design, create academic policies, run clinics, participate in accreditation, meet with students and prospective students, and make admission and student petition decisions. Unknown to most, staff make the classes happen, keep the building functioning, get the bills paid, stage events, help students find employment, keep the computers running, connect potential new students to SJCL, process applications and registration, run the library, connect with, thank and acknowledge donors, process financial aid, create school publications, and keep SJCL compliant with endless regulations.

I remember with great gratitude, the efforts of the alumni and staff on so many SJCL events this year – the Donor Wall reception, the Judy Wiseman Golf Tournament, the beautiful Barrister's Ball, the Hall of Fame reception, and others. Thank you to all SJCL donors that make it possible to sustain the academic program without large tuition increases.

However you celebrate the holidays, everyone at SJCL hopes it is a happy, healthy time filled with family and friends and that 2009 is a stellar year for you and yours.



## 2008 LECTURE SERIES Career Alternatives for Lawyers

Cindy Wathen's (Law '95) publishing credits include *Remembering Cesar: The Legacy of Cesar Chavez*, the first book to be endorsed by the Cesar E. Chavez Foundation and the winner of the Valley Independent Publishers gold medal award for history. She has worked as an acquisition coordinator for McGraw-Hill, senior editor and publicist for Quill Driver Books, and most recently, assistant acquisitions editor and art researcher for The University of California Press.

After working as a law clerk during law school, Cindy decided that she loved studying the law but not necessarily the profession of law, so she decided to explore the world of publishing.

After law school she worked for McGraw-Hill in the bay area and found that having her JD quickly made her invaluable. A few years

later she moved to another publishing house where she was able to really see how her law degree and publishing intersected. Many of the skills she learned in law school became very handy while preparing written and oral arguments for department heads on various manuscripts she was asking to be published. Some of the career alternatives Cindy discussed during her lecture included, working for a publishing house to negotiate author contracts-both literary and publishing-to include monetary compensation, royalty rates, author rights, copyright infringement and defamation issues, negotiating subsidiary rights such as foreign, television, and film, and working with legal scholars on manuscripts.

Another career option Cindy discussed is that of a Literary Agent. This person is literally a "literary lawyer" who finds authors and manuscripts to work with for the extent of the author's career. Their main purpose is to pitch the author's work to publishing houses, after, retaining 15% of all the author's earnings for life. It is a very lucrative field that is spreading throughout the United States, not just in New York City anymore. One good author can support a literary agent for the rest of their career.

The final career alternative she spoke about, that can be very beneficial to a lawyer, is writing a non-fiction legal book. This not only lends credibility in a particular area of law but can help build a career, a client list, increase speaking engagements, and help bring "focus" to a specialty. Free-lance writing for editorials, columns, and articles is also a way of creating platforms for specialized legal topics.

### 1978 Frank Gash

Frank finds it hard to believe that it has been over 34 years since he started law school at SJCL with the class of 1978. It was the late summer of 1974, Richard Nixon had just resigned from the presidency, and the Vietnam war was still in progress. Frank had just returned to Fresno after completing his military service commitment as a USAF C – 141 pilot flying combat airlift missions worldwide. No longer required by the "regs" to get a haircut, his hair began to grow, and grow, and grow. Pictures from that era reveal quite an afro on Frank Taylor Gash III. Yes, that really was a long time ago!

The transition from military pilot to law student caused Frank to miss flying, so he found a part time job as a fight instructor and charter pilot at nearby Chandler Field. ### **Marvin Helon**

Since graduating from San Joaquin and passing the bar in 1978, Marvin has worked at Helon & Manfredo LLP in Fresno. He had the benefit of learning from and practicing with his father, Marvin E. Helon, Donald F. Manfredo and James Gregory who were long-time respected Fresno attorneys. Marvin's practice has focused on estates, trusts, guardianships and conservatorships, where he has done both transactional work and litigation, and on transactional business law and real estate work.

Marvin has been married to Leslie A. Helon since 1979. They have two children, Matt Helon, age 26, and now a graduate student, and Megan Helon, age 21, and now in her senior year of college.

Marvin has spent years active in his kids' schools. He has served as a temporary judge and as a court appointed attorney and court appointed referee in probate matters. Marvin was also the chairman of the Fresno County Bar Association Probate Section.

He served on the Board of Directors of the Fresno County Bar Association. Marvin says he has the San Joaquin College of Law Alumni Association to "thank" for that. It just so happened (they say) that the annual notice from the Bar Association showed up with their list of persons nominated by the Board for election as directors and it had the still to be found statement that the general bar membership could nominate any other person with a petition and a specified number of signatures.

Marvin suspects that while "cocktails" were being served at the alumni meeting the conversation turned to "we don't know these people" or "we don't like these people" the Board nominated and if Helon has time for a vacation then he damn sure has time to be on the Board of Directors. The Alumni Association members apparently had enough members present to nominate him and when Marvin returned he found himself nominated and soon elected. Marvin was told by Val Wesson, then Executive Director of the Bar Association, they didn't quite know what to do, as they had never had (or could not remember) someone being nominated by the general membership, let alone then elected.

Marvin said his only interest is working. He does admit that he works too much but, then again, if he took a vacation, he might end up elected to something else. As to other interests, like a lot of guys, he likes sports and cars.

Marvin believes he was in the one (and only true) day class. He remembers being told when they started that the majority of them would not make it; out of about 60 that started in the day class only 18 graduated. Marvin was the youngest having come straight from college. He remembers it as the first time he really had put in much time studying.

### **Ysidro Macias**

In 1988 Ysidro and his wife took a trip to the "Big Island" of Hawaii. It was love at first sight-love in the sense he had already been thinking of leaving Fresburg and was looking for the "perfect place." This wasn't easy, given they had five kids and the oldest was just graduating from high school.

A friend recommended that they go to Kauai. During Easter of 1989, Ysidro took the whole tribe to Kauai and fell in love with the place because it reminded him of the Salinas Valley where he had grown up (agricultural, small towns). While there he made a ridiculous offer on a condo in Poipu Beach. The ridiculous offer was accepted with owner financing. Then he knew that his wife would be open to coming back since they had a piece of the island.

Ysidro put his "new-age thinking" into place and started projecting a possible move to Kauai. Sure enough all the pieces came together kind of magically. They went over in the fall of '89 and he took the bar exam. He managed to hire a hispanic woman practicing workers' comp for the State Compensation Insurance Fund who could handle his Spanish-speaking clientele in Fresno. Like clockwork, everything fell into place so that they moved in June 1990.

Ysidro practiced a "gentleman's practice" (very slow) on Kauai for 1 1/2 years until his employee notified him that she was moving on, and so Ysidro returned by himself for 1 year to take over his practice again (in Fresno) until he found another person who could handle the Spanish-speaking caseload. In the meantime, his wife proceeded with plans they had to open a Mexican taqueria, which turned into a restaurant. It opened in early 1992.

Hurricane Iniki hit the island in September 1992 while Ysidro was still on the mainland. Initially, the island was awash with federal monies and the restaurant was doing great. The good economic times continued until early 1994, when the federal monies dried up, and the island economy went into a deep funk.

Since the beginning of the restaurant, they had put a small tortilla machine in the back to make fresh tortillas, an item unknown in the islands at the time. In early 1994, the local Safeway store called, asking if Ysidro wanted to put their tortillas in the Safeway store because customers were asking for them. Ysidro became responsible for that portion of the family business. By the end of 1994, their tortillas were in all the stores on Kauai.

In late 1994 they called Costco, who told them that if they moved to Oahu their tortillas could go into Costco warehouses. Their #2 son and Ysidro moved to Oahu. They set up the tortilla operation with new larger machinery, and were off and running. Initially, the going was slow, as Hawaii consumers are white rice eaters and unfamiliar with tortillas. They doggedly kept plowing away, gaining small victories little by little and dealing with competition from another tortilla operation which opened up roughly the same time on Maui.

The Maui competitor went belly up in 2000, and they have steadily grown into becoming "Hawaii's tortillas" to the present day. Their main competition all comes from the mainland, Mission tortillas primarily.

Ysidro sold his law practice in 1994 and has never looked back. As he tells anyone interested, "I'm a lot happier feeding people than feeding off of them." I left all my suits on the mainland, including ties; shorts and T-shirts are my usual wear at all times, with "slippas," of course.


