## Celebrating the 37th Graduating Class

*On a sunny May 29th, 2010, 43 people saw the circumstances of their lives change forever; they were awarded Juris Doctor from San Joaquin College of Law at its commencement ceremony at the William Saroyan Theatre.*

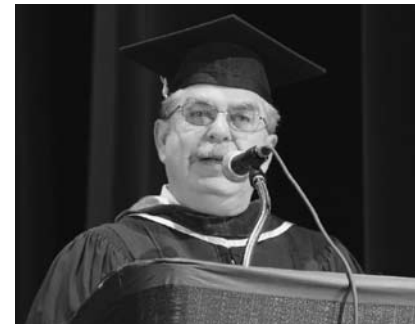

Commencement speaker, Assembly Member Juan Arambula urged the graduates to be passionate about their practice of law, especially when it comes to addressing problems in the Valley ranging from poverty and pollution to public safety, prisons, and public participation. Arambula drew laughter from the crowd when he referred to being the only Independent in the Assembly, saying he is a “party of one,” or a “party of Juan.”

Class Valedictorian, Jesse Fretwell, celebrated the entire class, reminding them that a home and money can be taken away, but their education is with them forever. That class initially arrived at SJCL bearing Bachelor’s Degrees from 17 different universi-

ties, including five U-C campuses and six California State University locations. Their majors ranged from Political Science to Mathematics, English, Psychology, Agricultural Business, Philosophy, Biology, Criminology, History, Business Administration, and more. They range in age from 24 to 46 years old. Some have children, some don’t. One has seven children, and two other students gave birth during their final year of law school.

Some came to San Joaquin College of Law as a legacy; Pauline Seiler is the daughter of SJCL Hall of Fame inductee Kathy Hart (Law ’77) and Jennifer Mele is the daughter of James Mele (Law ’76). Others did not have the benefit of such a role model; Monica Bermudez is the first person

in her family to graduate high school. She is also a single mother with a nine-year-old daughter who has commuted to law school from Visalia while working in the Tulare County Public Defender’s Office. That office was well-represented; classmate Ron Weber also works there and Public Defender Michael Sheltzer, an adjunct professor at SJCL, took his place on the stage of the Saroyan Theatre. In all fairness to the “other side of the aisle,” it should be noted that graduates Heather Pietroforte and Jessica Weatherly have been working as law clerks for Tulare County District Attorney Phillip Cline (Law ’78). Other graduates have held similar positions in Fresno and Merced Counties, and some have been working for other government entities, nonprofits, or private firms as they finished their studies.

*In the late 1960's, Superior Court Judge Dan Eymann felt the San Joaquin Valley needed a state-accredited law school. He invited a large number of local attorneys to his home for dinner to discuss founding such a school. I'm told that a number attended simply because Mrs. Eymann had a reputation as a fantastic cook. All who attended were invited to a second meeting. Only now United States District Court Judge Oliver Wanger and John Loomis returned. From the three of them, San Joaquin College of Law was born and opened its doors to its first class on September 4, 1970.*

I wonder if any of them envisioned where the law school would be 40 years later. SJCL attained provisional state accreditation in 1974 and full state accreditation in 1976. In 1980 it moved from the unique round classroom on the campus of Fresno Pacific University to the Shields Avenue building. In 1987, SJCL became a candidate for regional accreditation by the Western Association of Schools and Colleges. Multiple site visits followed with the school attaining WASC accreditation March 1, 1993. In 1997, SJCL moved to its beautiful facility in Clovis (which it is now close to outgrowing) and SJCL's accreditation was reaffirmed in March of 1999.

Following an intense three-year process, SJCL's regional accreditation was reaffirmed again in June of this year. This process entailed the preparation of four reports, including two massive self studies, the last totaling more than 2,000 pages of text, records, and statistical studies. It is an experience in self-evaluation and change. The WASC



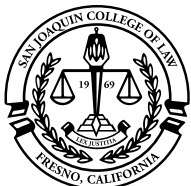
accreditation process is designed to help an institution improve itself. It has certainly served this function for SJCL.

As a practical matter from the students' perspective, reaffirmation of accreditation enables students to continue to receive federal financial aid. Financial aid has been critical to opening the opportunity for a legal education to all. On a larger scale, reaffirmation demonstrates that SJCL

is a serious institution committed to compliance with the standards of higher education.

For the fiscal year 1971-72, SJCL's total income was \$59,309. There were no full-time faculty and only part-time staff. Forty years later, for fiscal 2010-11, total income will be almost \$3.8 million with a full-time faculty of 8 and staff of 22, performing functions from recruitment, placement, financial aid administration and counseling to fundraising, public relations, and financial administration. A total of 212 students are enrolled. Over our forty years, 85% of the graduates who have attempted the bar examination have passed, and now practice in every conceivable arena of law.

This is an amazing transformation. Thank you to everyone who has played a role in this story – students, board, faculty, staff, and community friends. I hope to see many of you at one of the 40th Anniversary events. It would be such a pleasure to reminisce together.

# '98 Alumni Appointed Superior Court Judge

Merced County Chief Deputy District Attorney Mark Bacciarini (Law '98) was in court on June 30th, running his felony calendar, when his phone began to vibrate at 10:15 a.m. He quickly excused himself and stepped outside to call his wife, Lynda. Governor Arnold Schwarzenegger had just appointed him to the Merced County Superior Court bench.

The newly appointed judge gave little indication as to whether he was expecting that sort of call, saying only that those who are appointed are "always surprised."

The 52-year-old served as chief deputy district attorney for the Merced County District Attorney's office for the past year and was a deputy district attorney

from 2000 until 2009. He was an associate attorney for Morse, Morse, & Morse for two years following his graduation from San Joaquin College of Law in 1998.

Judge Bacciarini says he was "very serious during law school," which he attended as a second career. He admits he had no idea whether he was getting a good legal education until after he graduated. It was at that point he was happy to discover he found himself to be, in his words, "as well or better prepared than my adversaries." His stepdaughter, Kathryn Gates, is also preparing to be that well-prepared; she's a third year law student at SJCL. His other stepdaughter, Haley, is a freshman at Fresno State who is considering mirroring the Judge's BA in Music from UOP. Bacciarini's son,

Michael, is a freshman in high school.

Bacciarini says he didn't aspire to be a judge during law school, but that desire grew as he progressed through his career. In his new position, he fills the vacancy created by the retirement of Judge Frank Dougherty last November. Dougherty served nearly two decades on the bench. With this latest appointment, SJCL now has 15 alumni serving as judges, along with 6 Administrative Law Judges and 6 Court Commissioners.

SJCL Constitutional Law Professor Jeffrey G. Purvis took on topics ranging from gun control to health care reform in an appearance on KFJR's "San Joaquin Spotlight." That weekly show is hosted by SJCL Alumni Circle Member Sevag Tateosian (Law '08).



The San Joaquin College of Law Roundtable has soared to new heights since its inception in January. The weekly show airs Tuesdays during the noon hour on Bill McEwen's "Straight Talk" program. One show was broadcast live from elections headquarters at the invitation of Fresno County Clerk Victor Salazar (Law '93). Other recent shows featured Jennifer Walters (Law '04) on Grandparents' Custodial Rights, Tim Magill (Law '78) on Employment Law, Mark King (Law '05) discussing difficulties with the insanity defense, Bob Hirth (Law '96) on medical marijuana defense, and Teresa

Petty (Law '07) detailing legal issues surrounding the hiring of a care giver. The Roundtable has also taken on a "breaking news" tone at times, including an interview with Brenda Linder (Law '04) on the same day she represented four medical marijuana clinics trying to stop the Board of Supervisors from shutting them down. In addition, Alex Peltzer (Law '01) gave some legal perspective to the BP Oil Spill and Professor Jeffrey G. Purvis discussed Elena Kagan's nomination to the Supreme Court.

McEwen also interviewed SJCL Student Ashley Allred on her comment in the San Joaquin Agricultural Law Review titled "Solutions to a Stinky Problem: Congressional Legislation to Promote the Use of Cloth Diapers."

In addition, in our role as the Regional Academic Legal Resource Center, the law school has scheduled some non-alumni guests. Rene Lastreto and David Jenkins appeared in conjunction with the Central California Bankruptcy Association to talk about the "Fundamentals of Bankruptcy" program and attorney William Kreig discussed "lemon laws."

# SJALR – 20 Years and Growing

*On June 12, 2010, the San Joaquin Agricultural Law Review held its Welcome Luncheon for prospective candidates.*

The luncheon is a special occasion where the Editorial Board gives interested students an overview of law review candidacy. This luncheon was particularly special because it ushered in the Journal's 20th Anniversary. Twenty years ago, the San Joaquin Agricultural Law Review was established to provide a forum for scholarly articles written by students and attorneys that focus on legal issues affecting the nation's agricultural industry. Today, this year's Editorial Board, along with the boards of the previous two decades, continues to carry on this fine tradition. This year's Editorial Board consists of Editor-in-Chief, Lisa Cutts; Managing Editor, Ashley Allred; Executive Edi-

tor, Kyle Roberson; Production Editor, Erick Rhoan; and Notes & Comments Editor, Rachel Cartier. Together, they addressed the prospective candidates at the luncheon, giving them a general overview of the law review candidacy process. For Volume 20, the Board is utilizing two approaches to candidacy: a "fast track" that places candidates on a more rigorous schedule, aiming to front load much of the research and writing process during the summer to avoid a heavy work load during the fall; and the traditional schedule of deadlines that previous Boards utilized in past volumes. In addition, the luncheon featured Marcie Downing (Law '05), a member of the Journal's Emeritus Board and practicing attorney, who

gave words of wisdom and encouragement to the prospective candidates.

Lisa Cutts gave a brief introduction to the law review process and the two paths to candidacy. Rachel Cartier addressed the differences between a law student comment and a case note, as well as outlining the schedule for the "fast track." Kyle Roberson gave helpful tips to candidates on picking a topic. Ashley Allred addressed what the candidates will get, both academically and professionally, from writing a Comment or Case Note. Erick Rhoan gave the candidates a pep talk and directed them on what to do next. Afterwards, the Board took questions from the candidates and thanked them for attending.

Volume 20 will not only be unique, but it will feature the same level of high quality scholarship that it has displayed in the past. In addition to recruiting many excellent candidates, the Board members themselves are once again displaying their writing skills by writing small pieces for Volume 20. # Dean's Reception Welcomes Entering Class

They're all part of the new incoming class at San Joaquin College of Law, but some of the ties go deeper than meet the eye. At least three of the incoming classmates are "legacies," continuing a long tradition at SJCL where alumni family members enroll to continue the tradition of success. Also at the Dean's Reception, one incoming student was surprised to see he would be classmates with a girl he hadn't seen since she was a baby. Following Dean Jan Pearson's welcoming remarks, current students Lorena Garcia, Henry Campa and Christina Widner offered the students encouraging hints for success. Christina Widner, third year law student in



the four-year program, discussed the importance of forming study groups and using the practice exams to prepare for the midterm and final. She encouraged incoming students to seek out other students, faculty and family for support. Henry Campa, third year law student in the three-year accelerated program, talked about his initial thought process of wondering if "what he had was enough." As he transitioned into becoming a law school student he discovered "it is all about the mindset and believing in yourself, believing you can do it." He encouraged students to join student organizations and seek out upper class members for guidance. Lorena Garcia, fourth year law student in the five-year option discussed the importance of finding a balance between family, work and school. She advised incoming students to focus on quality of time verses the quantity of time. She acknowledged that she intentionally chose the five-year option so she could

make time for her husband and live a balanced life. She encouraged students to "enjoy the ride."

Aside from support from fellow students, the newcomers also felt the warmth of alumni pride. Civil Trial Attorney and SJCL Hall of Fame Inductee Michael Marderosian (Law '77) was among those to speak to the new students about having a passion for law, adding "The fire burns even brighter today than when I began this journey." He told the first-year law students that 37 years ago he was a grocery clerk at a Savemart Supermarket when he started at SJCL. Mick stated "the commitment to succeed comes with sacrifices." He stated law school is a life-changing experience. He talked about the pride students will acquire from reaching one's goals. "The fact that you could make money and have this kind of fun is actually a terrific experience," he said.

And Memories of Robert Gorman (Law '80) "In his own words."

When I entered SJCL in 1976, I already had 10 years of full-time teaching experience under my belt, the last 6 at Fresno City College. Through law school and until 2003 I continued to teach at Fresno City College while maintaining a small law practice, first with Edward Marouk and Linda Bonett, and later with just Linda Bonett. For 18 of those years I served as Hearing Officer and Counsel for the Fresno County Civil Service Commission because I had developed something of a specialty in Public Sector Labor and Employment Law. So my working career consisted of 37 years of teaching (33 at Fresno City College) and 23 years as a practicing lawyer. I retired from teaching and became inactive in the practice of law in 2003.

For many years until his unfortunate death in 2000, I provided legal services to, and was a business associate of, our classmate, Robert Gorman, whose chemical engineering consulting business was Industrial Process Consultants. Bob Gorman, much beloved by his classmates, for his Southern homespun sense of humor and because he was the oldest student, was a chemical engineer, who constructed and deconstructed chemical plants all over the world. I came to learn that Bob was intimately familiar with every ammonia, urea, and nitric acid plant in the entire world.

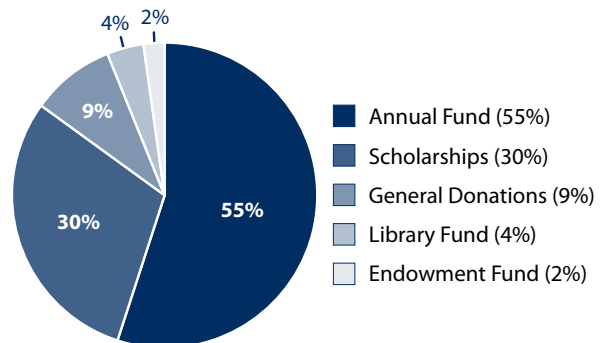
