New Members Named to SJCL Hall of Fame

San Joaquin College of Law welcomed three new inductees in the Fourth Annual Alumni Hall of Fame Reception and Induction, including a judge, a commissioner, and a district attorney.

Friends, family, and fans of the inductees and SJCL gathered for the celebration at the Robert E. Coyle United States Courthouse on October 28th. The event was co-hosted by SJCL and the Fresno County Bar Association, and sponsored by McCormick, Barstow, Sheppard, Wayte & Carruth, LLP.

All three inductees were chosen based on their high standards of ethics, professional competency, and achievements which have brought recognition and honor to San Joaquin College of Law. Master of Ceremonies Hal Bolen noted the ferocity of the competition for induction into the Alumni Hall of Fame. This year's inductees include:

Honorable Nancy A. Cisneros

As she took to the podium to collect her plaque, Commissioner Cisneros gave praise to SJCL, saying "the education I received was outstanding, the friendships I made everlasting."

Meanwhile, Hall of Fame Alumna Kathy Hart had high praise for Cisneros, noting "She never loses her optimistic vision or her voice of reason. She has a special, charitable view of humanity that is not shared by most of us. She believes everyone can succeed, and she believes that everyone – no matter how despicable they appear to the rest of us – has a heart of gold. I admire her unfailing optimism in the goodness

of human nature and her tireless and patient efforts to be both judge and life coach to the parade of needy defendants who daily appear before her."

Judge Hilary Chittick echoed that sentiment, saying it was hard to express how much Judge Cisneros meant to the participants in the Drug Court. At Drug Court graduation there would be tears and hugs with many participants saying that Judge Cisneros had changed their lives. She said thousands of people come through Drug Court and Judge Cisneros treats each one like they were the only one there.

Commissioner Cisneros retired from the Fresno County Superior Court in



Happy Holidays to all!

SJCL ends the year with so many exciting things happening and the promise of even more exciting things to come. I hope the holidays and the new year bring as many wonderful things to all the SJCL community.

here are so many projects SJCL would like to undertake in the new year – projects that are win-win-win. They would help students, help SJCL, and help the San Joaquin Valley community. There is so much need in our Valley. SJCL would like to develop a clinic to address some of this need.

One possibility would be assistance to abused women. The Marjaree Mason Center is considering opening a shelter in Clovis. The women in that shelter will be in desperate need of legal help and most will have no financial ability to obtain it. Marjaree Mason has some resources to assist them, including generous volunteer attorneys, but the need always outstrips the resources available. What if SJCL could operate a clinic to offer services to those women, both for Temporary Restraining Orders and/ or for any follow up legal assistance needed? This would be a wonderful public service. The FIRST win.

Legal education curriculum is moving rapidly towards greater emphasis on practical skills. Many SJCL students work as interns or law clerks during their legal education. In addition, SJCL offers a panoply of practice courses, including writing courses, Pre-Trial Civil Litigation, Civil Trial Practice, Advanced Criminal Law, Criminal Trial Practice,

and Mediation. In a clinic, however, students would put those skills into actual practice. A classroom component would permit more advanced training as well as student discussion of effective/ineffective techniques. This would be a powerful means of improving graduates' skills. The SECOND win.

To create this type of a clinic, SJCL would have to have an additional full-time faculty member to train and supervise the students, as well as teach. This individual would have to have a passion to create the clinic and mentor students.

The THIRD win is for the school itself. With the solid bar results of this November, SJCL is very close to satisfying the American Bar Association standard for bar passage. That standard says that for three of the last five graduating classes, 75% of the graduates must have passed the state's bar examination, regardless of the number of attempts. In fact, the classes of 2008 and 2009 have met that standard with the class of 2010 close after only one attempt. Having met that, the greatest barrier to SJCL attaining ABA accreditation is the lack of a sufficient number of full-time faculty. In addition, most ABA schools have at least one community clinic. Creation of a Family Violence Clinic, for example, and the addition of the full-time faculty member to shepherd it would be another positive step in that direction. As graduate David Hogue once said in a Board of Trustees meeting, "You either move forward or you move backward. You never stand still."

We are researching funding potential for this clinic – as well as for clinics on seniors' issues, support to non-profit organizations, and immigration. But we will also need your support. I will be visiting and calling many of you throughout the next year to talk about gifts to the SJCL Annual Fund to help make this happen. I so hope you will be as excited about this win-win-win as I am.

An Aside

The Legacy Luncheons held throughout the last three years for each of the graduating classes (and graduates in Hanford, Merced, and Tulare-Visalia) were a wonderful opportunity to reminisce with so many people. I was overwhelmed by the incredible success SJCL graduates have had in their careers and the diversity of their accomplishments. We plan to start the cycle again in September of 2011 - only this time we will be pulling together graduates who started law school together. So the luncheons will be reunions of entering classes - the people with whom you survived that horrible first year of law school! It should be fun!!!

Deanna L. Martinez

San Joaquin College of Law mourns the passing of Adjunct Professor Deanna L. Martinez on Friday, November 5, 2010, after a brief, unexpected illness. She is aptly described by Law Coordinator Pat Smith as "a wonderful and dedicated instructor" who will be "deeply missed by all." Professor Martinez taught at SJCL for more than a decade. She was in the process of teaching "The Federal Courts and the Federal System" at the time of her unexpected death at the age of 43. She has also taught "Law Practice Management" at the Law School, and began her years at SJCL teaching in the Paralegal Program.

Professor Martinez received her B.A. from the University of Pacific, Stockton, and her J.D. from Hastings. While at University of Pacific, Deanna was a member of the Debate team with state level recognition. She practiced civil litigation for several years before going to work for the United States District Court, and then on to a position as an Assistant United States Attorney with the Department of Justice.

Spotlight on Adjunct Professors

The hands-on practical engagement in law of our Adjunct Faculty adds a depth and dimension which contribute immeasurably to the education of our students.


s a general practitioner and mediator with the Gillett Law Of-Lice in Porterville, Professor Gillett brings a hands-on view of current trends in Business Law. He says he sees the effects of the economic downturn manifested in an increasing number of start-up businesses who find they hold contracts which investors or suppliers are either unwilling or unable to fulfill. While he stands prepared to "litigate, negotiate, or mediate to try to satisfy both sides," he adds amicable resolution "has never been such a good option" as it is now. That's because many of those defaulting on contracts are simply falling on hard times, and they will still be

around and open for business when good times return. He believes in a small community like Porterville, every business knows it will be working with the same people for decades to come and understands it's unwise to burn bridges.

Following Gillett's graduation from law school, he served as President of the Board of El Futuro Credit Union as a way to give back to his community. In addition, he serves on the governing board of the Porterville Unified School District. In law school, Professor Gillett served as the vice president of the Law School Association and was the Managing Editor of the UC Davis Journal of International Law and Policy.

Professor Gillett refuses to define his teaching style, adding he tries to develop that by assessing the needs and size of each class. However, he does try to carry a moral message to each potential attorney that they should be connected to their community and its needs. In his words, "It's important to be a public citizen." Just as he demonstrates that belief through both words and actions, he also demonstrates his belief in the value of education.

Professor Montoy combines her 20 years working in the Fresno City Attorney's Office, including more than a decade as City Attorney, with more than a decade of private practice focusing on municipal law, culminating with the opening of her own law firm in 2009. She currently represents public agencies in areas ranging from governance and contracts to public works, land use, CEQA, impact fees, labor relations, and more.





engaged in some way with SJCL, which is a great community resource." She believes knowledge about municipal law is useful in several areas of practice, adding that students entering her class should know "municipal law is vast and that the class is intended as a good overview to specific areas students may want to pursue such as constitutional law, land use, environmental law, (and) labor relations."

Professor Montoy brings not only experience, but also perspective to this area of law. She says it has changed since she began her practice in that "the number and complexity of laws has grown exponentially." As for the current challenges in municipal law, she believes there's no doubt many are driven by a dearth of dollars. "They include aging infrastructure such as roads, waste water treatment plants, and water wells; the inability to provide quality of life amenities such as parks; unfunded liabilities such as with retirement benefits; a concerned workforce; and the unwillingness of electors to approve funding."

Rosemary McGuire Appointed to the Bench

Governor Arnold Schwarzenegger has appointed SJCL Alumna Rosemary T. McGuire (Law '94) to a judgeship in the Fresno County Superior Court.

he judgeship was created by the conversion of a court commissioner position earlier this year. McGuire says she had been hoping for the appointment for the past couple years, but it was still a shock when the call came.

Since her graduation from SJCL, McGuire has worked for essentially the same law firm, now Weakley, Arendt and McGuire, LLP. The Clovis resident became a partner in 2001. Her practice has been primarily focused on representation of business, religious, and public entities, including child protective services liability, police liability, and civil rights litigation. While she says she is "thrilled" and her husband is "ecstatic" over the appointment, she believes it will be difficult on her partners, adding they are both partners "and good friends."

That partnership/friendship with Jim Weakley has now lasted 28 years.

Meanwhile, the announcement didn't seem to slow the work load for that partnership; the morning after the Governor's announcement, McGuire was in depositions in Southern California while her firm fielded an avalanche of congratulatory calls and e-mails, including those from SJCL. However, juggling seems to be a skill she learned long ago; she worked fulltime while attending law school and tending to her husband and two children.

She says she is honored to take her place on the bench among the other judges, adding she has "a lot of admiration for them." She also has some advice for students at SJCL, advising them to "set goals and work hard. It will happen!"

Over the years, Dooley has served on the Executive Committee of the UC Merced Board of Trustees, the Maddy Institute Board of Directors, and the California Historical Society Board of Trustees. She is also a past president of Planned Parenthood, the Visalia Chamber of Commerce, and the Central California Futures Institute.

Richardson has worked for CCLS for the past decade, carrying an incredible case load, but always managing to find time to squeeze in emergency cases. She is also a member of the Fresno County Domestic Violence Roundtable, trains volunteer attorneys for pro bono work with domestic violence victims through Project First Step, spent six years mentoring women freshly released from prison through Volunteers in Parole, and currently works with the Samaritan Women of the Fresno Rescue Mission.

Alumni Win Champions of Justice Awards

Congratulations to the Honorable Kimberly Nystrom-Geist (Law '92) and Lazaro Salazar (Law '03), winners of Central California Legal Services "2010 Champions of Justice" Awards! The awards honor individuals who have labored to improve access to justice.



Judge Nystrom-Geist received the Judicial Award for her focus on making the courts more user-friendly for self-represented litigants, including seniors and dependent adults. Since her appointment to the bench in 2005, she has created weekly elder abuse calendars, meaning those scheduled for such hearings are not left waiting for hours as other family law cases wind their way through the court. In addition, as the Family Law Presiding Judge, Nystrom-Geist is lauded for her close work with the CCLS Elder Abuse Prevention Project.



Lazaro Salazar was named "2010 Champion of Justice" in the category of Attorney/Law Firm. While he has worked closely with the Mexican Consulate on immigration matters for nearly a decade, he has also spent the last three years working with CCLS and other organizations to provide free consultation to those seeking citizenship. In one year alone, those collaborative efforts offered naturalization screenings for more than 2,500 people.

urrent law review candidates have the editorial board, faculty advisers and fellow candidates very excited as they are in the midst of submitting their final drafts. Candidates' hard work has paid off, resulting in six unique, timely, well-written Comments. Here is a sneak peak!

Christina Widner recommends a new regulation for puppy mills that takes into account current state and federal regulations as well as addresses the concerns set forth by Governor Schwarzenegger, when he vetoed a similar proposed California Assembly Bill in 2009.

Chester Walls analyzes the lack of federal regulation of wastewater reuse in the United States and argues that a congruent national policy that allows and encourages alternative sources for water, namely treated wastewater, to be used will help the agricultural community secure a safe, reliable supply of water for years to come.

Tim Bartell introduces a legislative recommendation for raw milk regulation that addresses questions of constitutional legitimacy of current raw milk regulation while still accomplishing its intended purpose of keeping consumers safe from the alleged dangers of raw milk consumption.

Michael Shaddix advocates a new government-subsidized program whereby agribusiness employers who utilize federal databases to verify the legitimacy of their employees as well as subject themselves to random and periodic checks for compliance will be deemed "USDA Certified Legal Producers", entitling them to label their products as such, and benefit from a government-sponsored advertising and promotion campaign aimed at increasing demand for these "legally produced" products.

James McCann proposes that the United States adopt one hundred percent duty-

free quota-free market access for all Least Developed Countries as an example to the international community to modify and conclude the Doha Development Agenda, forming it into a legally binding trade agreement.

Sam Brar analyzes the Federal Insecticide Fungicide and Rodenticide Act, and what power is retained by the States, in protecting their own citizens when they suffer adversely from the use or exposure to pesticides.

As always, in every volume of the San Joaquin Agricultural Law Review, there is a Professional Article. Each year, at least one Professional Article is needed to publish the journal and to continue our long-standing tradition of providing quality, agricultural legal issues to the legal community. The Twentieth Volume is a tremendous milestone and the Editorial Board hopes to receive many professional submissions.

The Alumni Circle closes out the year with a dizzying array of topics on the San Joaquin College of Law Roundtable. The host, Fresno Bee columnist Bill McEwen, has done a stellar job of preparing thoughtful questions for his guests on topics ranging from Cyber Intellectual Property with Dan Rogers (Law '08) and Adoption with Nancy Stegall (Law '96), to Foreclosures with Ofra Pleban (Law '96) and Laws Related to Animals with Adjunct Professor Stefanie Kraus-Cota (Law '00). Two of the shows have also given listeners a closer look at the Law School. One interview included a preview of Senior Citizens' Law Day with Marcella Downing (Law '05) and attorney Robert Howk. The other featured SJCL Professor Sally Perring and Fresno Pacific University Professor Duane Ruth Hefflebower on the Co-operative Degree Program, wherein students can simultaneously earn a Juris Doctorate and a Master of Arts in Peacemaking and Conflict Studies.

Many of the topics addressed by Alumni on the SJCL Roundtable came straight from the headlines. James Witherow (Law '87) talked about how the recommendations of the federal deficit reduction commission will affect those planning to receive Social Security. Bob Abrams (Law '08) discussed mortgage fraud perpetrated against those heading into foreclosure and unexpected taxes headed to those who lost their homes this past year. Lazaro Salazar (Law '03) talked about immigration issues, including the "Dream Act," affecting minors who arrived in this country illegally, but have lived here most of their lives; they include the Fresno State SBA president. Lori Mayfield (Law '94) highlighted the differences between domestic partnerships and marriages at the same time a three- member appeals panel of the U.S. Court of Appeals prepared to decide the Prop 8 question.



Alumni Circle members also responded to requests received at SJCL from reporters for legal commentary on various news stories. KJWL News Director Juanita Stevenson was looking for an attorney to respond to questions of possible civil rights violations after budget cuts forced the closure of roughly half the polling sites in Fresno County. Bob Hirth (Law '96) responded to that call. Meanwhile, Adjunct Professor David Mugridge (Law '85) responded to a call from KMJ reporter Margaret Carrero for comment on a potential case of a mental health patient being denied treatment due to a lack of insurance.

The Business Journal continues to expand its coverage of legal issues, trends, and attorneys, including interviews with SJCL Alumni Sevag Tateosian (Law '08) and Deborah Boyett (Law '01). March 2010, having served the Court in that position for 22 years. During her years on the bench, her assignments included Juvenile Dependency, Family Support, Family Law, Drug Court, Traffic, and Misdemeanors. She served in Drug Court for 8 years, where she developed her passionate interest in rehabilitative justice, especially for drug addicts receiving treatment rather than incarceration. Her impact on the many individuals who appeared before her in Drug Court was recognized by a Deodar Cedar planted in her honor in Courthouse Park.

Commissioner Cisneros received the Justice Pauline Hanson Award from Fresno County Women Lawyers and the Champion of Justice Award for a judicial officer from Central California Legal Services. In 1997, she was named the Commissioner of the Year by both the California Department of Social Services and the National Child Support Enforcement Association. She has been recognized for her work on numerous boards and commissions and remains a member of the National Association of Drug Court Professionals.

Phil Cline

As he accepted his plaque and place in the SJCL Alumni Hall of Fame, Phil Cline took a moment to reminisce about his family's humble roots, moving to the Valley during the Depression. He grew up in Farmersville, and credits SJCL for giving him, in his words, "an opportunity to be something different from what I was set up to be." After graduation from law school, Cline noted with glee that he felt highly qualified to take on the graduates of any other law school in the country, adding he would pull up to the courthouse in his Volkswagen, "go up against the Harvards and Yales, and just beat them like a drum!"

Nick Schuller (Law '98), a Deputy D.A. under Phil Cline, had high praise for his boss. "Phil Cline's record of accomplish-

ment clearly reflects the dedication and leadership worthy of induction to the SJCL Alumni Hall of Fame. He has served honorably and dedicated his career to protecting the community of Tulare County. Phil Cline is a prosecutor's prosecutor. He carries out his duties with determination to get the job done, resolve, and concern for his employees. He's an aggressive leader with creative administrative skills that produce results. Most important, Phil has taught me a lot about what it takes to be an effective prosecutor. I consider it a high honor to serve under his direction at the Tulare County District Attorney's Office. Without question the instant recognition is well-deserved."

Cline has dedicated his legal career to public service. His career has been spent as a prosecutor in the Tulare County District Attorney's Office. He started there as a student law clerk, working his way up the ranks from a line prosecutor doing misdemeanor and felony trials to supervisory positions, including specializing in homicide and death penalty prosecutions for seven years.

In 1992, he was elected District Attorney of Tulare County, a position to which he has been re-elected five times, serving a total of 18 years. Among his many noteworthy accomplishments, Cline created the State's first rural Crime Program designed to protect the agriculture industry from crime and potential threats to the food supply. The Program consists of County task forces of detectives and prosecutors, coordinated through D.A. Cline's office and covering the entire Central Valley.

Honorable Alan Simpson

The Honorable Alan Simpson gave a nod to the Law School as he was inducted into the Alumni Hall of Fame, noting one of its goals is "to provide opportunity without having to leave the Fresno area." Judge Simpson says he always wanted to be a judge. He

recalls as a small boy being in a courtroom one day with his father, a Sheriff's deputy. He says his father told him to go sit behind the bench. The view left a permanent impression, which he now passes on to young students who tour his courtroom.

His induction into the Alumni Hall of Fame drew praise from elsewhere on the bench. Judge Hilary Chittick said that Judge Simpson, as the Presiding Judge of the Civil Division, is the major reason there is no backlog in Civil, even though the number of cases is up. Past inductee Judge Gary Austin described him as "always helpful, willing to work long hours, and take on any assignment given him gladly – a true team player."

Hall of Fame Alumna Kathy Hart added Judge Simpson "has this ineffable, idiosyncratic, special insight that makes everyone want to hear his opinion. I have always appreciated his special worldview. I don't know quite how to describe it, but like they say about obscenity, 'I know it when I see it.' He is like the bright sunshine that dissolves the stormy clouds of dissent. When I hear him speak, I am transported to the Enlightenment and to the Age of Reason."

The Honorable Alan Simpson graduated from California State University Fresno in December of 1977 with a degree in Political Science. He worked for approximately six months as an eligibility worker for the Fresno County Department of Social Services. He then joined the District Attorney's Office as a Welfare Fraud Investigator.
