Alumni surveys always yield surprises. When SJCL alumni were recently asked what

goals the school should set for the next 5 and 10 years, the most frequent response was the attainment of ABA accreditation. Making ABA accreditation a priority is, of course, a major policy decision for the Board of Trustees, but certain recent events may make the prospects for success brighter.

First, most ABA accredited institutions hold library collections

of a minimum of 100,000 bound volumes. The annual upkeep and space requirements for such collections are staggering. Maintenance of SJCL's currently 23,000 volumes cost \$90,000 (excluding personnel costs) in fiscal 1994-95. Sustaining massive hard bound collections seems inefficient with the advent of WestLaw/Lexis and CD Rom technology. In reality, SJCL students have access to hundreds of thousands of volumes through those systems, often directly from their home computers.

The ABA, however, has been slow to recognize computer access as an acceptable substitute for lesser used resources. Now the ABA has launched a study and reconsideration of its library standards in light of computerization. Recognition of computer access may be a benefit to smaller institutions like SJCL.

Second, the ABA has recently agreed to reexamine the manner in which it accredits law schools in response to pressure from the Justice Department about potential anti-trust violations. In particular, the ABA agreed to drop its requirement that a law school seeking accreditation pay its faculty and admin-

istration at levels comparable to other ABA-approved schools. In addition, the ABA

agreed to revamp its accreditation criteria with regard to teaching loads and student/full-time faculty ratios. These rules have disadvantaged institutions like SJCL which emphasize teaching and skills over research and more heavily utilize practitioners as adjunct faculty.

The final form of any new rules is unknown, but they may

recognize the value of alternative approaches to legal education that are successful. This would improve SJCL's chances of success and, therefore, its ability to make all options available to its graduates.

Third, to fill its own needs, SJCL has taken steps that would also be critical to ABA accreditation. The new building is utterly essential. SJCL has now taken possession of the site. With each investigation we find new features of the building that will ultimately turn it into a facility beyond most expectations. It will be a prize for SJCL and the City of Clovis.

Further, SJCL's newly hired librarian, Terri Rogers, comes to us from an ABA institution. SJCL's student population hovers at the critical mass for accreditation. The bar passage rate is climbing, and SJCL's default rate on student loans is admirably low at 3.2%.

When Judge Eyman, John Loomis, and Judge Wanger founded SJCL in 1969, surely ABA accreditation was just a gleam in someone's eye. It may not be the unattainable dream anymore.



As the Director of Financial Aid, Gwen sees a majority of SJCL students at some point

of their education. "I enjoy working with the students vs. the impersonal numbers. I realize how important financial aid is; a lot of SJCL students couldn't come here without it."



Gwen finds that the biggest challenge of her job is keeping up with all the rules and regulations for all the different kinds of financial aid such as the student loan programs, federal grants, work-study and V.A. benefits. "There are constant regulatory changes and the challenge is making sure that we stay in compliance."

When Gwen first started at the law school in 1992, she was the Administrative Assistant to the Paralegal Program, and she helped out in law admissions, financial aid and the accounting department. As the amount of paperwork and the student population of SJCL grew, she moved to half-time in both financial aid and the paralegal program. Next, she became a full-time Financial Aid Officer. Law Review Enters Sixth Year

The San Joaquin Agricultural Law Review is both an organization and a publication. As an organization, the San Joaquin Agricultural Law Review is guided by a national editorial board and an advisory committee consisting of individuals with broad experience and demonstrated success in the agricultural, legal and business communities. The organization is further guided and supported by members of the administration and faculty of San Joaquin College of Law.

As an annual publication, the San Joaquin Agricultural Law Review is the single law-school-sponsored law review in the country devoted entirely to agricultural issues. A board of editors consisting of students of the law school manage the day-to-day operations of the Law Review and exercise complete autonomy over the selection of articles and other materials to be published, as well as producing the publication itself.

The Law Review has several purposes. It is first and foremost a vehicle to challenge San Joaquin College of Law students who have demonstrated superior academic achievement and a commitment to sound legal research to extend their education beyond the traditional classroom environment. Editors, staff and candidates alike function as members of a team focused on the production of a scholarly work designed to meet the needs for information and analysis of contemporary issues in the areas of agriculture, business and the law.

It is this dissemination of information which lies at the heart of the *San Joaquin Agricultural Law Review*. The 1995 edition, volume 5, contains a symposium on federal marketing orders. Variously praised and criticized by industry representatives, and generally maligned by consumer advocates, marketing orders are often misunderstood by those not directly influenced by them in the agri-business community. Marketing orders are least understood by the vast majority of consumers who depend upon a national food distribution system deeply affected by mar-

keting orders to provide them with adequate supplies of high-quality fruits, vegetables and dairy products at affordable prices. Volume 5 provides readers with information about the complex legal dimensions and real-world effects of marketing orders in a manner which the seasoned veteran is likely to find stimulating and the novice to find readily understandable.

Equally topical, but more regional in scope, volume 3 of the San Joaquin Agricultural Law Review contained a symposium on the Central Valley Project Improvement Act. The lifeblood of California agriculture water is also an essential element of survival for the state's urban centers, which represent some of the nation's largest cities. The series of articles presented in the symposium was intended to

distill the legal aspects of a complex, multifaceted subject to their essence, thereby providing the reader with critically important information in an accurate and timely manner.

First published in 1991, the San Joaquin Agricultural Law Review is entering its sixth year of serving the educational needs of San Joaquin College of Law students and the informational needs of agricultural, business and legal interests throughout the country. The value of the Law Review to participants and readers alike is seen in the editors willingness to address significant, sometimes controversial, issues in a scholarly manner and to produce and disseminate meaningful, accurate information of contemporary interest.

So, how do enterprising students become members of the Law Review? Students who place among the top 20 percent of their academic class, or who place at the highest levels of their first-year legal research and writing classes, are invited to become members of the Law Review. A write-on competition is conducted at the beginning of each academic year to afford other capable and committed students the opportunity to participate in and benefit from the Law Review experience. Those students who choose to become a part of the Law Review not only add a unique dimension to their law school education, they also help enhance the inventory of information and knowledge upon which members of the agricultural, business and legal communities rely.

The Law Review enters its sixth year recognizing that the commitments in time and resources by students, faculty and friends are essential ingredients in its success. It is with grateful appreciation that the Law Review acknowledges contributors in the opening pages of each volume.
