# Law Alumni Profiles The Class of 1978

This year is the TWENTIETH Anniversary of the graduation of the Class of 1978. This graduating class is unique because it included SJCL's one full-time, day-only class. Of the 48 graduates of the Class of 1978, half began in Fall of 1974 in the night program and half began in Fall of 1975 in the day program. Throughout 1998, in no particular order (well, actually, the order in which I was able to reach them), *Inter Alia* will highlight the lives of the graduates of 1978. I look forward to talking with each of you soon.—Dean Jan.

#### MICHELE BELANGER-McNAIR

Michelle became a litigator almost before she became a law student. She began clerking with the District

Attorney's office at the end of her second year of law school. In January of 1977, she became part of the Sexual Assault Team, working with and learning from another SJCL graduate, Lee Sterling. By the time Michele graduated from law school, she had already handled 13 jury trials. In her fourth year, Michele handled Juvenile Court cases under Judge Creede's watchful eye. She was a veteran of the courtroom when she graduated.

After graduation, Michele immediately joined the D.A.'s

offices as a Deputy D.A. She worked for the D.A. for 10 years, three with the Sexual Assault Team, and was the first woman to achieve Senior Deputy status. In January of 1987, Michele left to open a private practice. Her practice emphasizes plaintiff's personal injury litigation. A recent highlight was obtaining a judgment of \$847,000 for a client in a P.I. case.

Michele is involved with Fresno

County Women Lawyers, and has volunteered with Fresno Unified School District's Mock Trial and the Cerebral Palsy Association's VIP Program. She serves as President of Opportunities Plus. In 1992, she was named the Boss

of the Year by the Fresno County Legal Secretaries' Association.

Michele has two step children
- a daughter, Heather, who is a
marketing executive for Gottschalks,

and a son, Corey, who is an engineer for Cummins Diesel and father of Michele's only grandchild, Zach. She loves golf -currently carrying an 11 handicap - as well as skiing, scuba diving, and travel. Michele remembers starting law school at the Fresno Pacific facility. She was a young married woman who had never had to study to do well in school. The first night 70 people attended John Loomis's Contracts class; only 45 were left the next night in Judge Eyemann's Torts class. She says in 1974 when her class was admitted,

everyone wanted to go to law school, so admission was very competitive. She devoted a minimum of 40 hours per week to studying, but eventually (obviously!) got the hang of it.

# Law Alumni Profiles The Class of 1988

passing the bar, Mr. Eldridge hired him as an associate. By the time Mr. Eldridge died in 1985, Jim was a shareholder and the firm became Eldridge, Anderson & Weakley. On January 1, 1997, Jim opened a new firm with another SJCL graduate, Ben Ratliff hence, Weakley & Ratliff. Jim's practice focuses on defending public agencies in civil litigation. Currently, all of the lawyers and clerks working at Weakley & Ratliff are SJCL graduates or students.

While working with Peter Eldridge, Jim had the opportunity to participate in many complex civil defense cases against outstanding plaintiff's counsel.
