# Law Alumni Profiles The Class of 1978

This year is the TWENTIETH Anniversary of the graduation of the Class of 1978. This graduating class is unique because it included SJCL's one full-time, day-only class. Of the 48 graduates of the Class of 1978, half began in Fall of 1974 in the night program and half began in Fall of 1975 in the day program. Throughout 1998, Inter Alia has highlighted the lives of many of the graduates of 1978. It was a pleasure visiting with them and catching up on their busy lives.—Dean Jan.

#### MARY ANN BLUHM

After taking the bar exam, Mary Ann went to work for Harris & Bagdasarian. On her first day, she went downtown to pick up her company car--a brand new Mazda RX-7. On her second day, she met with the interior decorator to order all new office furniture. Reality hit shortly thereafter, and the firm dissolved before the furniture ever arrived. Mary Ann moved as an associate with Gary G. Bagdasarian to a modest twoattorney office, without even a plain paper copy machine, where she did transactional work. Later the firm moved to a building also housing attorneys Charles S. Poochigian, Steven M. Vartabedian, Charles L. Reed, Nick Wyrick, and Paul S. James.

In June 1980 Mary Ann and her husband, Dave, moved to southern California, where Dave worked as a training director for State Farm Insurance. Mary Ann opened a general practice law office in Camarillo, five minutes

from their home, under the firm name of Bagadasarian & Bluhm.

One year later Dave was transferred again--this time to Modesto to serve as an agency manager. Mary Ann took some time off work to start a family. She gave birth to Gabriel in 1982 and Joel in 1984. During this time she helped Dave with his office work

and did some contract work, including research

writing assignments for a blind attorney.

Mary Ann was planning to return to part-time work in January 1985, but instead spent 35 days at the Stanford University Medical Center, where Joel was being treated in the intensive care unit as he was experiencing frequent seizures throughout the day and night. Mary Ann eventu-

ally learned how to tube feed Joel at home and care for his special needs, but she and Dave decided to return to Fresno, where they would be closer to both of their families and Valley Children's Hospital. Upon returning to Fresno, Dave resumed his career with State Farm as an agent.

Two weeks after her

youngest son, A.J., was born in 1985, Joel was in the hospital again for one of his many stays. In 1986, Mary Ann's brother, John P. Eleazarian, who was then a partner at Kimble, MacMichael &

Upton (KMU), introduced her to a KMU law clerk and SJCL student, W. Richard Lee, and his family. Through the Lees, Mary Ann learned of a Philadelphia-based program that taught parents how to help their brain-injured children. She and Dave began an intensive home program for Joel, with the help of a cadre of volun-



Russ and Sharon recently celebrated their fifteenth wedding anniversary. They have two sons and two daughters between them. Russ and Sharon became grandparents last year and are expecting their second grandchild in 1999. Russ and Sharon enjoy local travel, most recently to the Napa

Valley, but as Russ says, since he has always been a workaholic, there isn't much time for running around.

Russ has fond memories of law school in spite of all the work.

One of his fondest memories is the way the class worked together with the common goal that everyone succeed.

#### TAMERA TRINDADE

Upon graduating from law school, Tamera immediately moved to Yuba City. Her husband, Roger, had been transferred there. Tamera took the BAR-BRI review and the bar examination at McGeorge. Passing the bar that November, she went to work for an insurance defense firm in Yuba City, Rich, Buidge, Morris &

Sandbrook. Two years later, Roger was transferred again--this time--to Redding. Tamera joined the firm of Halkides & Morgan in Redding, where she worked for a year. In 1990, Tamera opened her own practice in Redding, doing criminal law, juvenile deliquency hearings, and business litigation. Three years ago, she bought her own building two blocks from the courthouse. Tamera worked her way through the chairs in the Shasta and Trinity Counties Bar Association, culminating with a stint as its President in 1993.

Tamera clearly loves life in Redding. Her home is in the mountains--a 12 minute commute to work that includes only four stoplights. The weather is milder teers, some of whom have been helping her for the past 12 years.

In 1986, Mary Ann began her relationship with KMU, working two afternoons per week. She took a leave of absence in 1987 when Joel's condition worsened. That year, Joel required two surgeries at UCLA, one to remove the left side of his brain and the other to place a shunt. The surgeries brought his seizures under control (prior to the surgery he sometimes had more than 100 per day) and eventually allowed him to learn, with great effort, how to hold up his head, crawl, creep, and stand. Joel has yet to walk or talk, but eating is a favorite activity. He communicates nonverbally and continues to make incremental progress toward his goals.

Mary Ann was able to return to KMU on a part-time basis in the latter part of 1987, as the firm allowed her to maintain a flexible work schedule designed around her full-time, seven-daysper-week program for Joel, which required trips to Philadelphia every five months for evaluations. Mary Ann took some time off from 1990-1992, to have more time for her family, then returned to KMU on a part-time basis in 1992, after A.J. was established in kindergarten.

In 1994, Mary Ann had to leave again to fight her own, ultimately successful, battle with cancer. She spent a year at the California Court of Appeal, Fifth Appellate District, as a part-time senior research attorney while she was undergoing and recovering

from chemotherapy, then tried her hand at full-time work for a few months. This left her too little time for other pursuits, such as helping at school and being a fan at her sons' baseball and football games, so since May 1996, she has again been working part-time as counsel with KMU.

The Bluhm family enjoys sporting events, particularly

Upon graduating from law school, Mike entered private practice for four years. He then joined the staff of the State Compensation Insurance Fund working as a litigation attorney, first in Bakersfield, then Fresno, and ultimately as the Managing Attorney of the Salinas office.

Mike and his wife have three grown children, two of whom were born during his law school career. Mike says he loves his job but it does consume most of his time. What little free time he has is spent walking, working

out, reading, and watching sports.

Mike remembers that all his time was spoken for in law school, too. He was working full-time as well as attending school and had small

children. He remembers constantly striving to stay up with work and Saturdays and Sundays in the library. Only Friday night was set aside for time off with his family.

#### PAUL HINKLY

Paul began practicing law with Frank Gash. Ed Hunt joined them until Ed and Frank went to the District Attorney's office in 1982. By that time, John Suhr had also joined the firm and they practiced as Hinkly and Suhr until 1989. In 1989, Paul joined the Public Defenders' staff. Paul served on the Board of the Alternative Sentencing Program for the last six years.

Paul is married and has two children from a prior marriage. His daughter is an assistant manager at a pet products discount store in Lafayette. His son is in high school in Fresno. Paul enjoys golf, softball, and travel.

Paul's principal memory of law school is the good company. He, too, remembers being extremely busy working full-time, going to school, and taking care of a first child.

### Congratulations to July 1998 Bar Passers

The results for the July Bar Examination were released on November 20, 1998. According to the California State Bar, the overall pass rate for the July 1998 exam dropped nearly 10 percent from the July 1997 exam. Of the 7,580 people who took this year's July exam, 52.5 percent passed, compared to a 62.9 percent passage rate last year. However, SJCL had a 56.4 percent passage rate for first-time takers of the July 1998 exam. Law schools accredited by the California Bar, but not by the ABA, had a pass rate of 36.8 percent for the July 1998 exam.
